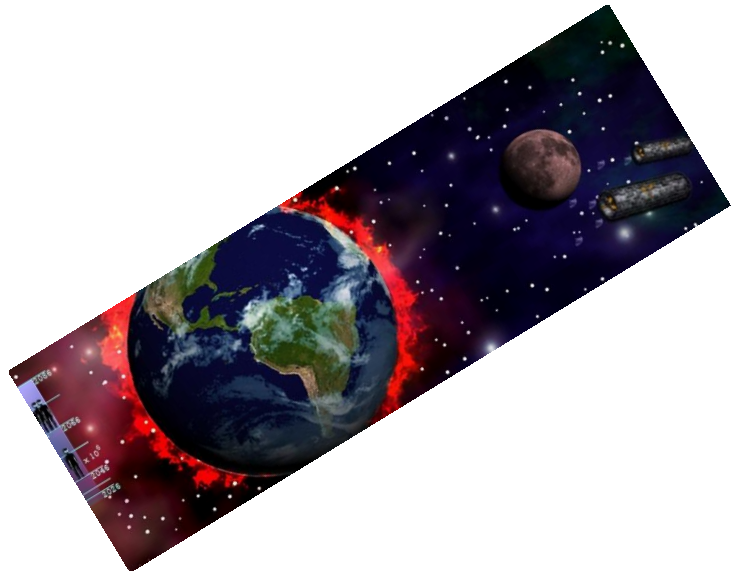
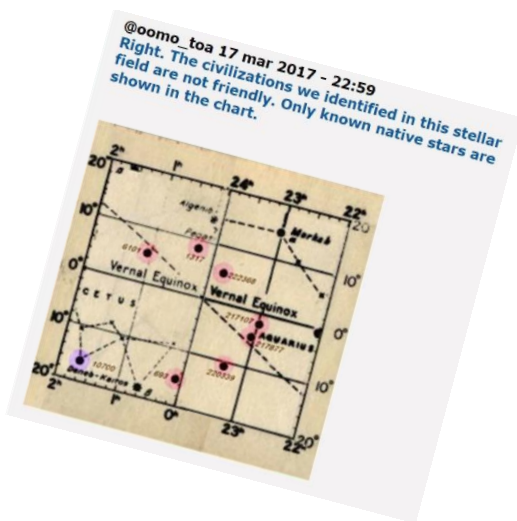

Chapter 1

Introduction

This report presents, in a summarized way, everything we know at this time, with great reliability,¹ about the current (and past) presence of extraterrestrials on our planet. The data provided essentially come from the information provided by the so-called *Ummites* or, as they prefer to be called in English, **Oomoans** — we will stick with this denomination for the ethnicity and ‘Um-mite’ as the adjective.

The information has been provided through various channels, some of which are still open. Such channels are:

- (a) The letters received between 2011 and 2014 by a Spanish-French group (called “GR1 letters”).
- (b) Electronic messages sent from 5 accounts via the Twitter network. Three of them were shut down some time ago, while the last ones, **@oyagaaayuyisaa** and **@312_oay**, remained active until December 31, 2024.
- (c) To a lesser extent, some old letters from the period 1966-2009, including the so-called “French letters” (2003-2009), whose authenticity has finally been credited along with (a) and (b).

What follows is a synopsis of all available information. Such information was not provided in the relatively structured and orderly manner in which it is presented here; on the contrary, it is the result of putting together many scattered pieces of a great puzzle that is still incomplete, but advanced enough to give a meaningful idea of what is happening.

Many texts, particularly among the most recent ones, are in English, but French and Spanish languages have also been used by the Oomoans. Translation will be provided when needed.

¹The reliability granted to this information will critically depend on the reader’s knowledge of and confidence in the *UMMO Affair*. (Pronounce ‘OOMO’ in English.)

It should be clarified that much of the following information has been provided directly and explicitly, but there are also some rather deductive statements, resulting from combining diverse data — sometimes separated in time and/or revealed in apparently unrelated ways — provided by the Oomoans. Even in these cases, we believe that our conclusions can be considered reliable, as they are logically deduced from the original information with very little room for discussion.

Finally, we will also hazard some conjectures of ours that we consider rather reasonable and likely, but in any case, whenever we mention them in the exposition, we will make their hypothetical character explicitly clear in order to avoid misunderstandings

Phrases or words literally reproduced from an Ummite source will always be written inside quotation marks, in italics, and in **brown** color. Occasionally, in the literal quotations reproduced (fully or partially) in this section, we sometimes chose to highlight some words or phrases using bold font. It is understood that the **emphasis is added by us**, unless indicated otherwise.

“We wish to develop with you, for centuries to come, bonds of fraternity fostered by our mutual similarities”

(Tweet from @oomo_toa of 18-2-2016, in response to a question as to why they care about our fate.)

Chapter 2

Number of known civilizations

The Oomoans know 74 planetary civilizations, and have verified the existence of another unidentified 3 (see Figs. 2.1 and 2.2).¹ Presumably, these 3 unidentified civilizations are of a higher or much higher scientific-technological level than the Oomoans themselves. (At least one of them certainly is; see Chapter 4).

Of these 74 + 3 civilizations, 31 have access to interstellar travel (almost certainly, only intra-galactic — see Figs 2.3 and 2.4).

Of these 31 civilizations, at least 23 have traveled to the Earth.

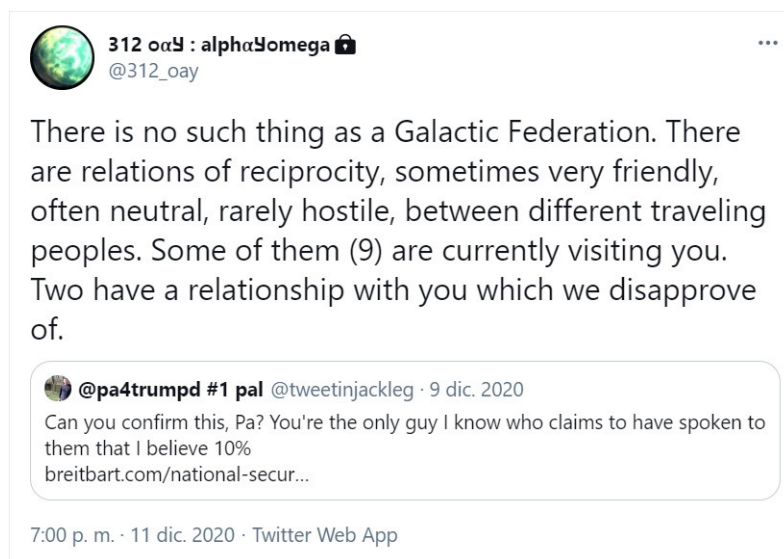


Figure 2.5: Tweet 312-18 (12/2020). No “Galactic Federation” exists, and number of visiting civilizations in December 2020.

Of these 23 civilizations, 18 have done so frequently. It might be supposed that they continue to do so, but a more recent tweet stated that, as of December 2020, only 9 civilizations were visiting us; see Fig. 2.5.

Most of the visiting civilizations are benevolent and limited fundamentally to observing, faithful to a universal ethic that determines non-interference. They do not intervene, therefore, or intervene in a limited way. However, there are exceptions (unfortunately for us). Of the 23 visiting civilizations, 3 are “amoral” and, of these 3, 1 is directly “hostile.” Actually, from now on we will always speak of the *hostile civilization* and of the *two amoral civilizations*.

Chapter 3

The “hostile” civilization

The “hostile” civilization, of an unspecified age but within the range of 5-6 million years¹ (the terrestrial civilization is about 4 million years old,² and the Ummite about 9 million; more on this in Chapter 5),

***“wishes to extend its colonies to OYAGAA [the Earth]
not hesitating in forcing you into submission.”***

The Oomoans then state categorically:

“We will not allow it”

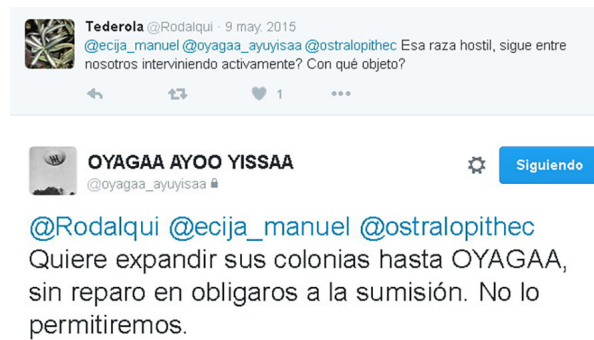


Figure 3.1: Tweet OAY-5 (05/2005). Question: “Is that hostile race still among us, intervening actively? With what purpose?” Answer: “**It wishes to extend its colonies to OYAGAA [the Earth] not hesitating in forcing you into submission. We will not allow it.**”

(Fig. 3.1) and indicate that for this purpose they count on the collaboration of other civilizations (probably two) that share their same ethical principles.

The hostile civilization is subject to a policy of “ostracism” and strict rules have been imposed on them, non-compliance with which involves “coercive measures.”

The hostile civilization prevents its already subjugated civilizations from traveling across the space. The Oomoans do not come close to those already colonized planets to avoid “a conflict.”

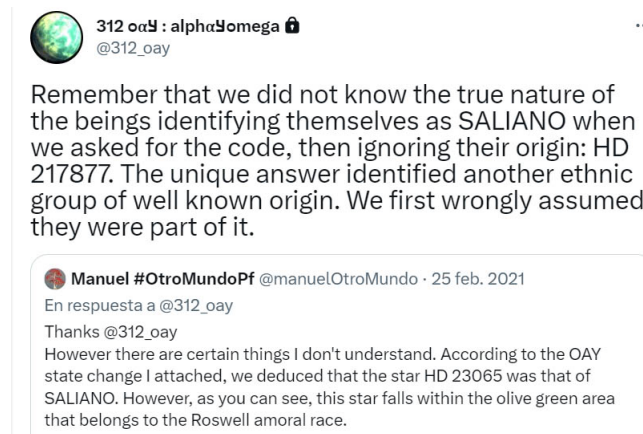


Figure 3.3: Tweet 312-43 (02/2021). The “Saliano” people first lied to the Oomoans about their origin.

The whole of the information provided by the Oomoans seems to allow connecting the hostile civilization with the ‘SALIANO case,’ which took place in Spain in the 1960s, in which several people were subjected to a mental manipulation experiment³ — see for example Fig. 3.2. The origin of the hostile civilization is the star HD 217877, in the constellation Aquarius — Fig. 3.3

More details on this civilization and their (now neutralized) plans are provided in Chapter 9.

¹“Age” refers to the time elapsed since the hominization.

³“There were some exceptions. An expeditionary group sent agents to various countries in Asia and Europe. Two of them arrived in Spain before ABAEXII 4 son of ABAEXII 3 put his body in contact with the Iberian Peninsula for the first time. Years later they connected through their brain control equipment with a Japanese citizen living in Madrid and later, through him, with another OEMMI called Fernando Sesma Manzano.

This civilization, very advanced in the studies of the Brain Network and its function in the Multicosmos, saw a very interesting occasion for them to use Earth humans as guinea pigs for their neuropsychological experiences.

Endowed on their Cold Astro with a civilization structured according to strict moral bases, they disregard the UAA that oblige the rest of us to respect the evolution of other Cold Astros with inferior civilization.

With absolute disregard for the biological integrity of Earthmen, they chose a large sample of unfortunate humans and subjected them to mental manipulations.

Chapter 4

Exogenous interventions against aggressive civilizations

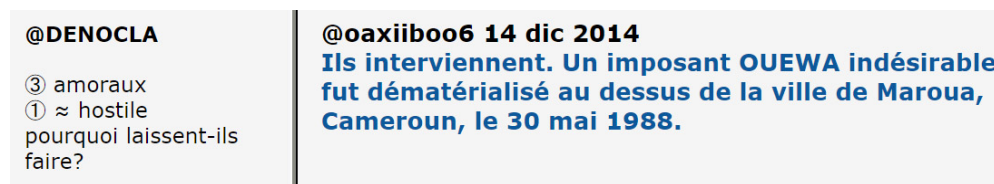


Figure 4.1: Tweet O6-108 (12/2014). Question: “3 amoral, 1 hostile... Why are they allowed to act?” Answer: “They do intervene. An enormous, unwanted OUEWA was dematerialized over the town of Maroua, Cameroon, on May 30, 1988.”

When a twitter follower asks why the most advanced civilizations (implicitly referring to the 3 unidentified ones, and assuming they are ethical) do not intervene to prevent the plans of the amoral and the hostile ones, the answer is that they do intervene, and a concrete example is cited: the “*dematerialization*” of an “*enormous*” “*undesired*” spaceship over the city of Maruá, Cameroon, on May 30, 1988 — see Fig. 4.1.

After reading this information, a twitter follower found a piece of news about a strange “meteo-logical” phenomenon recorded at the date and place mentioned:

L’EST RÉPUBLICAIN - Sunday, June 5th, 1988 - (page 133) -

[Translated from French]

Cameroonian Nightmare

A sudden night fell on Maroua and the northern city of Cameroon on monday afternoon for about ten minutes.

The phenomenon occurred at 3:45 p.m., when the sun was at the Zenith and it was very hot.

Suddenly, a thick ochre coat spread over the city, while a wind [the Harmattan] of rare violence blew, tore trees and lifted mounds of sand.

As this cloud covered the city, the population locked themselves in fear in the houses and lit the lamps. Public lighting had to be turned on along the city's arteries.

Ten minutes later, the night disappeared and gave way to a torrential rainfall that reached the capital Yaoundé.

A similar phenomenon had already occurred in Maroua in 1986, under similar conditions and at the same time of day. Strange, strange, strange.

This should be related to some paragraphs contained in a 2003 letter (<http://www.ummo-sciences.org/fr/NR-13.htm>):

“[t]here is a tacit pact of non-interference between the different OEMMII travelers who visit other stars inhabited by life forms more evolved than simple multicellular organisms. (...) The only common sense sanction we would apply to OEMMII who violate this tacit agreement would be a total refusal to cooperate with them and the implementation of specific, possibly coercive, means to counter their actions. There would be no destructive punitive sanction against these visiting OEMMII, except in the case of a manifest willingness to do harm, which as far as we know has not occurred strictly on Earth. In that case the OEMMII group that was most at hand to intervene would be free to do so provided they could justify this act of legitimate assistance to the other OEMMII brothers in the galaxy. (...)”

“[T]hus there is a race of OEMMII whose technology is beyond our comprehension and who seems to watch the different planets by probing the OUEWA [ships] that enter them. We can affirm that some OUEWA have been deliberately dematerialized within your atmosphere by what we have interpreted as an OAWOLEIIDAA [change of spacetime frame, or loosely speaking, 'jump to another universe'] provoked in an exogenous way to those ships, and we suppose, by those OEMMII of advanced technology.”

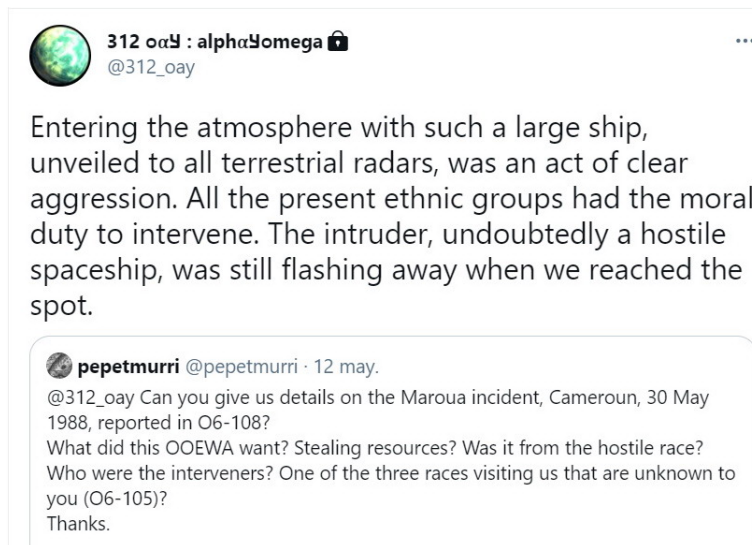


Figure 4.2: Tweet 312-66 (02/2021). Identification and dematerialization of a hostile ship over Maroua (Cameroon) in 1988.

Although the tweet O6-108 (Fig. 4.1) does not make clear to which civilization the dematerialized ship belonged, subsequent information indicates that it was a hostile civilization; and one must assume, at least for the time being, that it was *the* hostile civilization, as there is no indication in the information provided of the existence of another. See Fig. 4.2.

Chapter 5

Objectives of the amoral civilizations

The “amoral” civilizations play a more sibylline and *much more dangerous* role for us, since, unlike the aggressive, “hostile” civilization, which has been fully neutralized, as indicated in Chapter 3, the amoral races carry out their plans in a way that, apparently, the Oomoans and other friendly civilizations cannot openly confront by force.

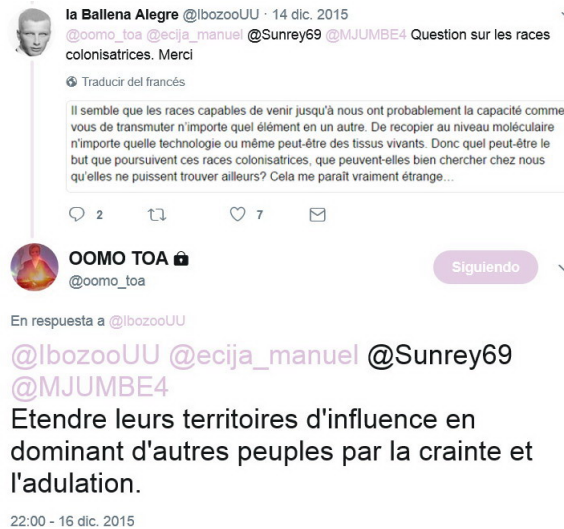


Figure 5.1: Tweet OT-45 (12/2015). Question: *“It seems that the races capable of arriving here have the ability like you to transmute any element into another. To copy at the molecular level any technology and even living tissues. [NOTE: The latter turns out to be not true, as we will see in Chapter 18.] So what can be the objective pursued by these colonizing races, what can they look for in us that they cannot find elsewhere? This seems strange to me.”* Answer: *“To extend their territories of influence, dominating other peoples by fear and flattery.”*

The two “amoral” civilizations are devoted to extending their *“territories of influence by dominating other peoples,”* not *manu militari* through invasion and downright colonization, like the hostile civilization, but through *“fear and flattery,”* taking advantage of the weaknesses of the coveted planets and signing pacts with them that, ultimately, leave them in a situation of subjugation — see Fig. 5.1. The term used by the Oomoans to describe the sad situation in which the deceived civilizations are trapped is *“under control.”* These dominated civilizations, once they have the space travel technology (provided in usufruct by the corresponding amoral civilization within the framework of the signed pacts), can carry out such expeditions — contrary to the colonies of the hostile civilization; see later — but always under the supervision/control of the race to which they are subservient.

One of the two amoral civilizations has an age in the range 4-5 million years; that is to say, in the same (broad) range as the Earth. It has semi-colonized (so to speak) 6 planets in total, 4 of which are in the range 3-4 My (million years), 1 is in the range 4-5 My, like the Earth and AM1 itself, and 1 is in the range 5-6 My — that is, this planet is older than its colonizers. The Oomoans refer to this “empire” as the **“SECOND DOMINION”** in this part of the Galaxy.

The other amoral civilization, which gives rise to the **“FIRST DOMINION,”**¹ has an age in the range 7-8 M-years and has 5 planets under control, 4 in the range 3-4 My and 1 in the range 5-6 My. We notice that the Ummite civilization is older than the hostile one (at least 3 My) and than the amoral ones (at least 3 My and 1 My, respectively).

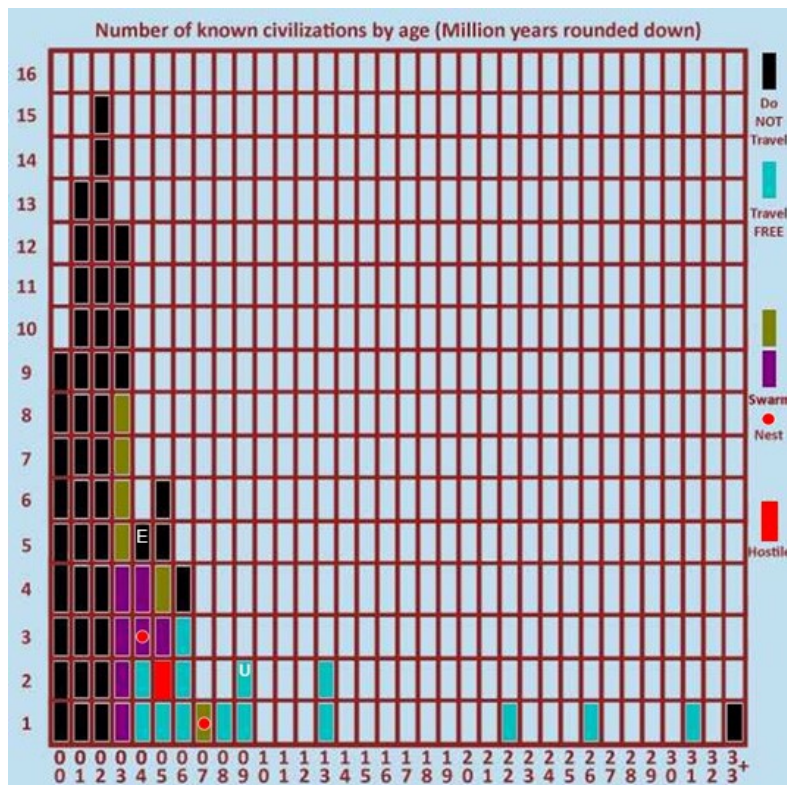


Figure 5.2: From tweet OT-40. Planetary civilizations identified by the Oomoans. Explanation in the text.

Fig. 5.2 is a slightly improved version of the table of known civilizations provided in the tweet OT-40. Each rectangle represents a civilization. We have added an E to indicate where the Earth is, and a U for Ummo. We see that, in the age range of 4 to 5 million years, is the Earth along with

four other civilizations (known by the Oomoans). Ummo is in the 9-10 million year segment, along with another civilization. Civilizations in turquoise blue (U, for example) have access to intragalactic travel and are free.²

The red rectangle identifies the hostile civilization which, had it not for the fortunate presence of the Oomoans and two other civilizations, would have colonized the Earth by force, as they have already done with a number of technologically inferior civilizations, to which they maintain in “servitude.” Their unfortunate colonies are some of the planets represented with black rectangles in the left zone of the picture. The color black indicates that the civilization does not engage in interstellar travel,³ either because of its limited scientific-technological development (like the Earth itself), or because it is a colony of the hostile civilization, or, as we will see later on, because it has already been seized by one of the two amoral civilizations.

The amoral civilizations corresponding to Dominion 1 and Dominion 2 are represented in the picture by a light brown rectangle and a purple rectangle, respectively, with a red dot above in both cases. These two planets with red dot are therefore the “nests” from which the respective “swarms” have departed. They have colonized 11 other planets in total, each of which is shown in the scheme in purple or brown color, depending on the civilization that has dominated it.

²The two allied civilizations are not specified in the table, but they must undoubtedly be two of the turquoise blue rectangles.

³The most advanced civilization (33 million years, at the far right of the table) appears in black because it no longer wishes to travel “physically” — perhaps they continue their explorations through unmanned automatic ships.

The 11 colonized autochthonous civilizations can travel through space thanks to the technology “graciously” provided by their “partners,” but under their dominance. The autochthonous civilizations will always be subordinate to them. It is the common goal of both amoral civilizations that the Earth should enlarge their list of submitted planets, by means of the cunning methods described previously.

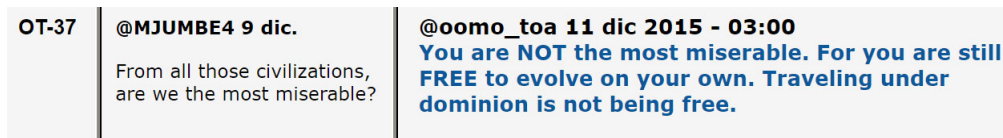


Figure 5.3: Tweet OT-37 (12/2015).

A Twitter follower, after seeing the list of civilizations, asked: “Of all these civilizations, are we the most miserable?” The answer couldn’t be more forceful (Fig. 5.3):

“You are NOT the most miserable. For you are still FREE to evolve on your own. Traveling under dominion is not being free.”

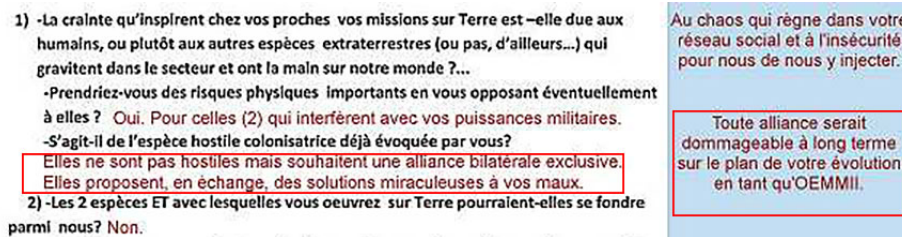


Figure 5.4: Part of the image-text of Tweet OAY-30 (06/2015). *“They’re not hostile, but they want an exclusive bilateral alliance with you. In return, they offer miraculous solutions to your misfortunes.”* *“Any alliance would be detrimental in the long term to your evolution plan as OEMMII”* [human beings].

The following is said of these two amoral races (see Figs 5.4 and 5.5):

*“They’re not hostile, but they want an **exclusive bilateral alliance** with you. In return, they offer **miraculous solutions** to your misfortunes.”*

(Regarding the last statement, Chapter 14 explains its relation to the ‘Crop Circles.’)

In response to the question *“Broadly speaking, what would the socio-economic model proposed [by the amoral civilizations] be?”* the Oomoans answer in a short tweet (Fig. 5.6):

“1 - Abundance = territories in exchange for technology.”

“2 - Restriction = services by technologies.”

Some clarification of these eerie remarks is given in Chapter 17.

The lapidary phrase accompanying Table 5.2 requires no further comment (Fig. 5.7):

“To avoid domination, do not sign any pact.”

Chapter 6

Eschatology of amoral civilizations

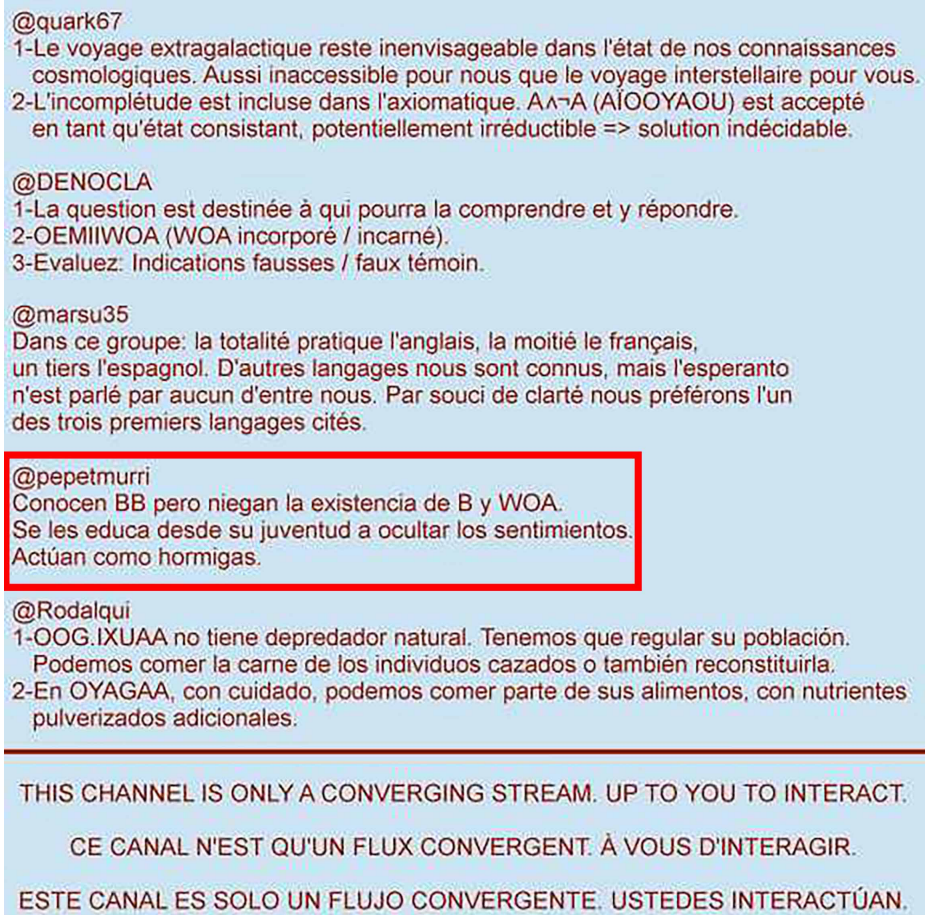


Figure 6.1: Tweet O6-77 (12/2014): Question: "Are amoral or hostile humanities unaware of the existence of B, BB, Oembuaw [link between B and BB]? The nequentropic perspective of morality?" Answer: "They know BB but deny the existence of B and WOA. From their youth, they are educated so they will hide their feelings. They act like ants."

In view of the astonishment caused by the assertion that some very ancient, technologically advanced civilizations ignore the scientific foundations of Morality, the Oomoans explain that these amoral races *“know BB”* (the Collective Soul, specific to each planet), but *“deny the existence of B* [the individual soul] *and WOA* [God]”. Of these beings they say that *“they act like ants”* and that *“from their youth, they are educated so they will hide their feelings.”* (Fig. 6.1.)

All this seems to indicate that amoral civilizations have a very strong gregarious character, in the worst sense of the term; individuality is practically annulled (they do not believe in the individual soul) and so is freedom. It would also seem that its expansionist policy is facilitated by the lack of consideration for other civilizations, who naturally do not share their BB. By denying the existence of WOA, they probably dismiss any universal moral precept regarding proper behavior with other civilizations, and, in any case, their 'impersonal' mentality very possibly disdains the individual consequences: the particular fate of an ant has no relevance compared to the global fate of the colony, which is the only important concept, everything in in the anthill being subordinated to it. With such a philosophy, it is hardly surprising that these civilizations have

“morally repugnant plans” for the future of the Earth, as indicated in an Ummite letter from 2012.

As if it wasn’t enough with the disturbing clues given about the intentions of these two civilizations toward our human civilization on Earth, one later tweet on the subject makes the previous assertion *“Any alliance would be detrimental in the long term to the plan of your evolution as OEMMII”* look almost a delicate euphemism. Asked by a follower, *“Can you delve deeper into the differences between the two amoral races? Which is the most dangerous? Role of each in the ‘NWO’ [‘New World Order’] contract?”*, the reply of the Oomoans is breathtaking (Fig. 6.2):

“Both would alike turn your descendants into unemotional healthy bodies, mere AAGAOEMII [domesticated men] legally hired by godlike masters for futile rewards.”

Chapter 7

The 'Reptilians' (1st Dominion)

The Oomoans attempted an official rapprochement with US authorities (official or *de facto*) many decades ago (Fig. 7.1). Their proposals were rejected (more details in Chapter 14). On the contrary, *“unofficial”* (and certainly concealed) relations *“subsist”* to date *“within plurinational military organizations, such as NATO”* with *“unscrupulous”* visitors. These beings are *“erroneously”* referred to as *“reptilians”* (presumably the name was given to them by their first Earth interlocutors). The denomination is due to the aspect of these ETs: *“pale-white skin,”* with *“ophidian skin appearance,”* and also endowed with a *“whistling language.”*

Thus, beyond their aspect, it is deduced that these beings are not reptiles at all: they are mammals indeed — just as, according to the Oomoans, it is determined by the universal cosmobiological laws concerning hominization.

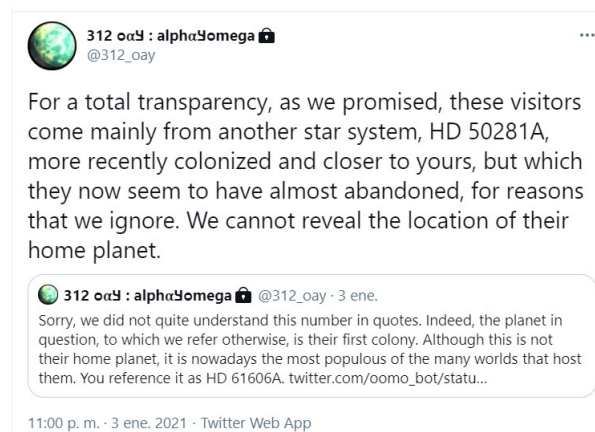


Figure 7.3: Tweet 312-28 (01/2021).

The 'Reptilians' come from the *Orion* constellation, and their dominion also extends to *Taurus*. The Oomoans say they cannot reveal their home star, but inform that HD 6160A is their first colony and *“nowadays the most populous of the many worlds that host them”* (Fig. 7.2). The visitors to Earth, however, come specifically from HD 50281A (Fig. 7.3).

The reptilians first arrived on Earth about 35,000 years ago (Fig. 7.4) and are the oldest known visitors. Other details about their past and current presence are deferred to Chapter 18.

Chapter 8

The 'Grays' (2nd Dominion)

The second amoral visitors are the well-known 'Roswell Grays.' In the 2003 aforementioned letter, the Oomoans explained:

"[W]e have the authorization to enter your social network since 1948. Previously all permission to visit your solar system had been denied to us. We didn't even know you existed. (...)"

"Recently, however, there had been violations of this ban by other visitors from a solar system that we did not know about. These small-sized OEMMI had rudimentary but unconventional technologies that surprised the brothers who regularly watch your planet. The latter did not have time to contact them to dissuade them from interacting. Your governments were thus accidentally aware of the presence of these visitors and their technology, advanced from your point of view. This situation unwanted by us needed a rupture of the strict non-interference policy that was in place for your planet. (...)"

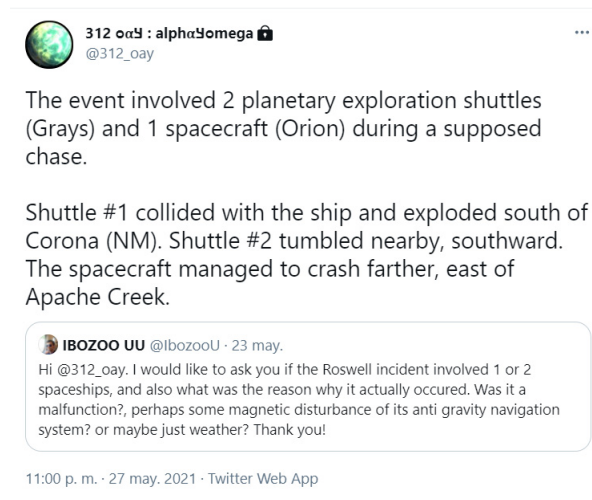


Figure 8.1: Tweet 312-70 (05/2021). The Roswell incident involved both grays and reptilians.

Are they talking about the Roswell case (1947) in the second paragraph of this quote? Indeed, the Roswell case has been validated by the Oomoans. It involved a **triple** crash (Fig. 8.1):

"The event involved 2 planetary exploration shuttles (Grays) and 1 spacecraft (Orion) during a supposed chase.

Shuttle #1 collided with the ship and exploded south of Corona (NM). Shuttle #2 tumbled nearby, southward. The spacecraft managed to crash farther, east of Apache Creek."

As said, the Grays or 'Roswell Aliens,' whose home planet has not been revealed by the Oomoans, constitute the 2nd Dominion of this part of the Galaxy; see Fig. 8.2.

The appearance of the Grays has already become, as the Oomoans themselves say, an archetype; see Fig. 8.3:

“This is an archetypal representation of what you would call the Roswell Aliens. Some shape and size dissimilarities have occurred over time between different families scattered across multiple host planets. But they keep this main deceptively frail appearance with big dark eyes.”

Incidentally, the Grays may be erroneously thought to be able to communicate telepathically with humans (which is impossible between different planetary civilizations, according to the Oomoans). This is due to the fact that they do not use the mouth to speak: *“Unlike Earthlings, the Gray visitors can speak through vibrating membranes inside their forehead. They can produce very tight directional [ultra]sound waves perceived only inside a small area. As they hardly move their mouths, it can be wrongly assimilated to a kind of telepathy”*; see Fig. 8.4.

Chapter 9

The Hostile (3rd Dominion)

We have no information about the physical appearance of the hostile race (apparently, “Saliano”) leading the 3rd. Dominion, but the Oomoans have provided us with a short description of their *modus operandi*:

“Worlds dominated by hostile factions are considered as belongings, as well as all local life forms. Resources, such as water, are slowly drained by the invaders. Most of the inhabitants are kept in a primitive state, with the exception of local rulers enslaved to their masters.”

(More about the plundering of natural resources in Chapter 18.) See Fig. 9.1.

The hostile civilization is subject to a policy of ostracism by the Oomoans and allies (Fig. 9.2), and strict rules have been imposed on them, non-compliance with which involves coercive measures, as said in Chapter 3.

The hostile visitors, however, still can and are trying (without much success) to seize the Earth by methods based on deception that are partly reminiscent of those of the two amoral civilizations; see Figs. 9.3–9.5:


“They [the hostile] obviously represent a danger for any civilization on the edges of their influence sectors. But, being officially coveted by the other two powerful dominions, seizing your solar system is no longer a realistic option for them. Unless you naively respond to their bait signals.”

“The famous astronomer F. Drake detected such a bait signal in 1960. But he was immediately deceived by the Army and diverted from his project, which had to be officially restarted later, as a cover. Other signals have been received and properly acknowledged as inimical in nature.”¹

“Clear warnings have been given to senior military officials of the main nations, concerning the ambivalent character of the various peoples in your immediate neighborhood. Albeit most of them have been ignored, others, in respect to these signals, were manifestly taken seriously.”




Chapter 10

Location of the Amoral and Hostile dominions

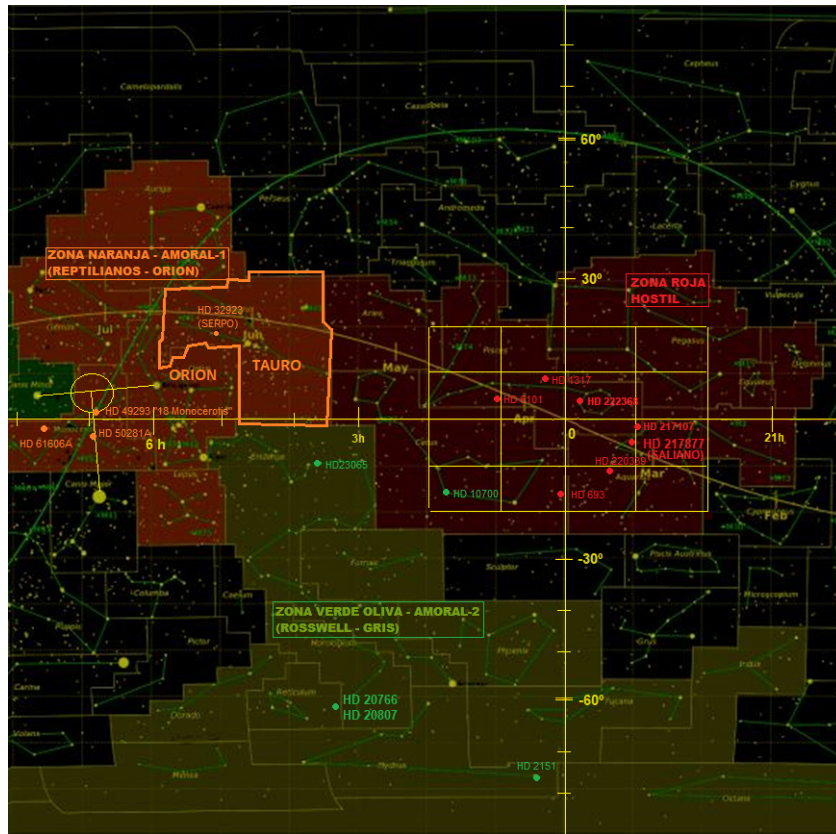


Figure 10.2: Improved version of the low-resolution map originally displayed in Tweet 312.

A stellar map indicating the dominions of the hostile and amoral civilizations was finally provided in February 2021 — see Figs. 10.1 and 10.2.

It should be noted that *Zeta Reticuli* belongs to the Gray or Second Dominion, but does *not* contain any inhabited planet:

“Although it is strategically included in the area of influence of the beings you denominate as Grays, this stellar system does not host any inhabited planet. Here is the chart of the [nearest] known civilizations in this specific area. Only one of them is really able to travel.”

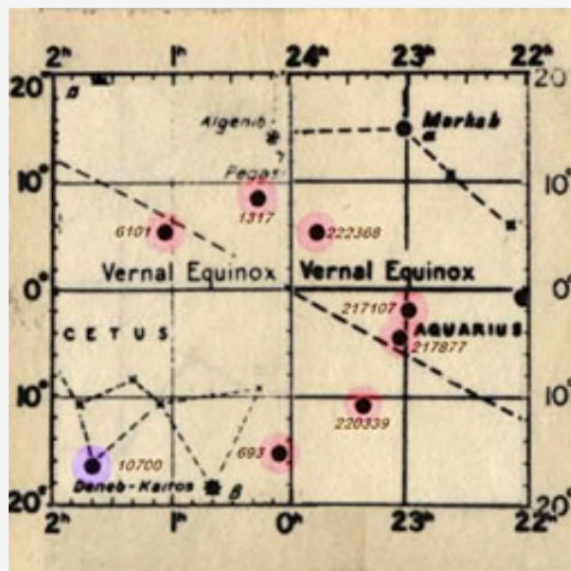


Figure 10.4: Tweet OT-87 (03/2017) The pinkish stars (and the purple one?) are identified as belonging to the 3rd Dominion (hostile).

A few stars related to the hostile dominion were also given in a tweet (Fig. 10.4).

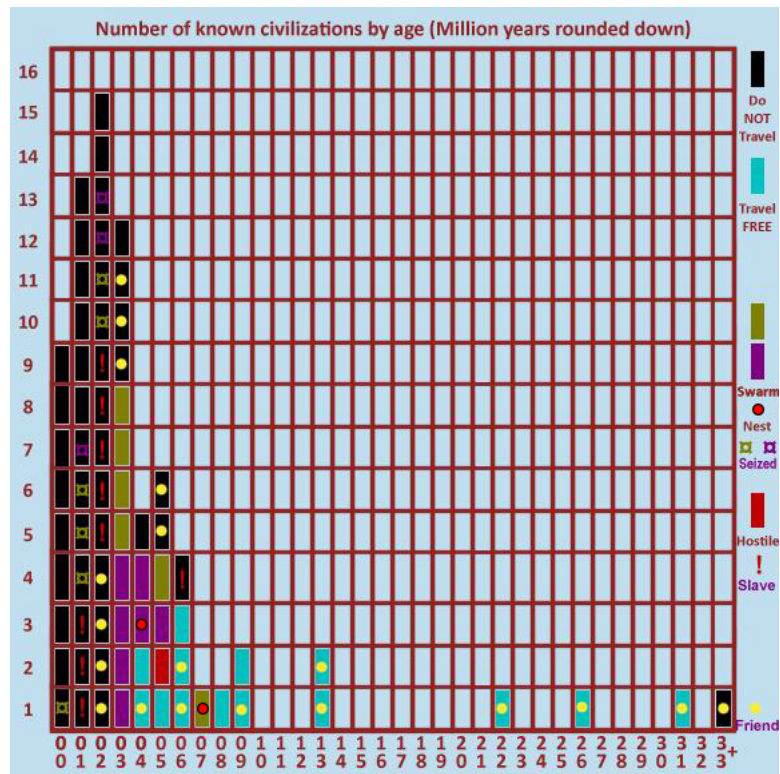






Figure 10.5: Slightly improved copy of the table found in Tweet 312-50.

It remains to be known how many and which of the black rectangles in Fig. 5.2 correspond to unfortunate worlds enslaved by hostile civilization. There are nine of them. This information was provided by means of the table in Fig. 10.5. The table, furthermore, indicates that some of these planets that have not acceded to space travel have already been “seized,” not by the hostiles, but by the amoral civilizations, either the Grays or the Reptilians. The ‘KAAIOEMII’ or *friends* of the Oomoans are also marked with a yellow dot. Note that they include non-traveling (‘primitive’) civilizations. Unfortunately, with its collection of psychopathic rulers and demented masters, the Earth cannot be included in this list.

The original tweet (Fig. 10.6) reads:

“Indeed, we maintain friendly relations with non-travelers. Interference with them is only di-

dactic and remains acceptable as long as technological exchange is not the goal. We welcome on OOMO all travelers who wish to exchange serenely with us. We send below an improved diagram."

Chapter 11

Eisenhower, Area 51, William Cooper, and Bob Lazar

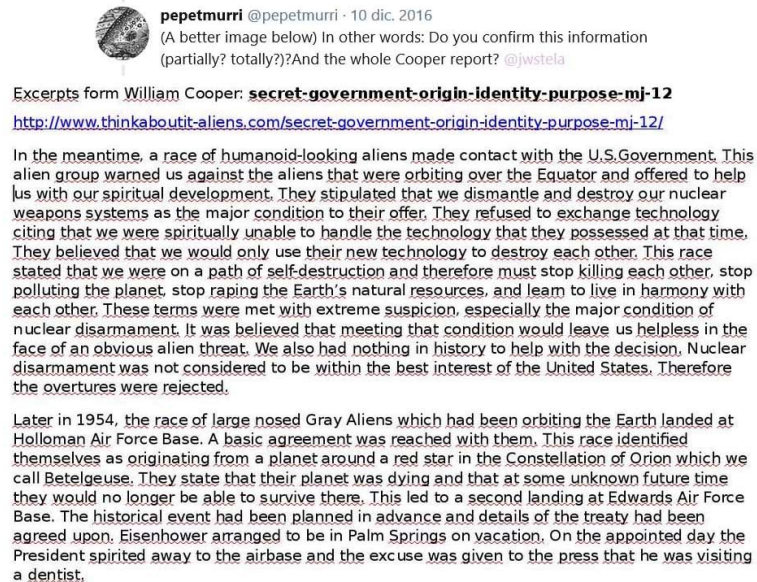


Figure 11.1: A Twitter follower asked whether this account ↑ by William Cooper was accurate.

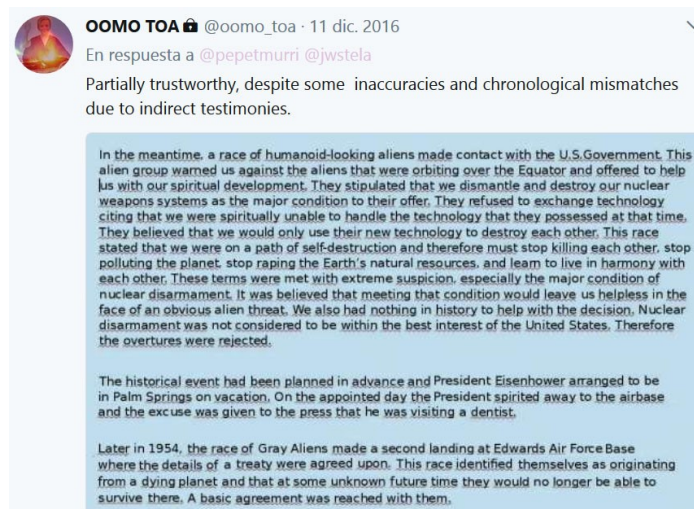


Figure 11.2: Tweet OT-83 (12/2016). Answer to the question in Fig. 11.1

Disclosure advocates are acquainted with a bunch of stories that have been circulating for decades about alleged relations between the US government (or those who control it) and one or more extraterrestrial races. In the jumble of more or less fantastic or baroque theories, there are some common elements that appear repeatedly... Some of these data have been confirmed by the Oomoans, by delivering a partially, but not substantially, modified fragment of a text written by the late researcher William 'Bill' Cooper (see Figs. 11.1 and 11.2). The edited text reads:

*"In the meantime a race of humanoid-looking aliens made contact with the U.S. Government. This alien group warned us against the aliens that were orbiting over the Equator and **offered to help us with our spiritual development. They stipulated that we dismantle and destroy our nuclear weapons systems as the major condition to their offer. They refused to exchange technology citing that we were spiritually unable to handle the technology that they possessed at that time.** They believed that we would only use their new technology to destroy each other. This race stated that we were on a path of self-destruction and therefore must stop killing each other, stop polluting the planet, stop raping the Earth's natural resources, and learn to live in harmony with each other. These terms were met with extreme suspicion, especially the major condition of nuclear disarmament. It was believed that meeting that condition would leave us helpless in the face of an obvious alien threat. We also had nothing in history to help with the decision. Nuclear disarmament was not considered to be within the best interest of the United States. Therefore the overtures were rejected.*

The historical event had been planned in advance and President Eisenhower arranged to be in Palm Springs on vacation. On the appointed day the President spirited away to the airbase and the excuse was given to the press that he was visiting a dentist.

Later in 1954, the race of Gray Aliens made a second landing at Edwards Air Force Base where the details of a treaty were agreed upon. This race identified themselves as originating from a dying planet and that at some unknown future time they would no longer be able to survive

there. [Note Cooper’s mention to Orion has been deleted, making clear that the contact was not made with the Reptilians.] *A basic agreement was reached with them.*”

Let us compare the outcome of the events narrated in the preceding paragraph with the statements in a tweet previously published by the Oomoans (first framed paragraph in Fig. 7.1): *“Your major military powers know perfectly well our presence as well as our intentions. An official approach was attempted, several decades ago now. The exclusively military objectives of your leaders made it quickly expire.”*

Therefore, the mysterious expression *“exclusively military objectives”* of the tweet would now be clarified in light of the events confirmed by the Oomoans. It might also be the case that the “humanoid-looking” aliens who warned the U.S. Government about the danger of the ‘Grays’, were the Oomoans themselves.

In July 2020, the account @312_oay retweeted a tweet from @WellandTribune concerning an article on Bob Lazar: *“Evidence suggests UFO whistleblower **Bob Lazar was telling the truth all along.**”* (See Fig. 11.3.)

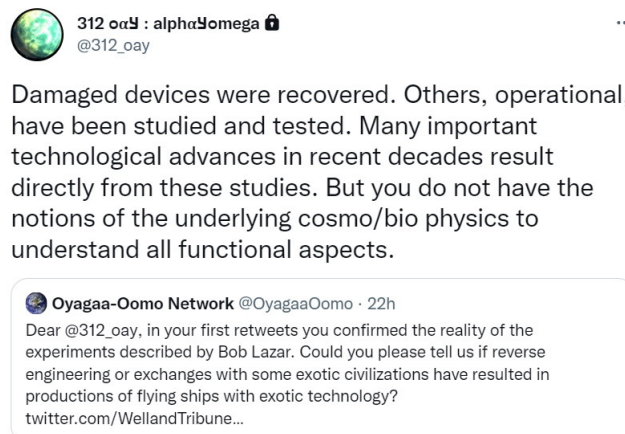


Figure 11.4: Tweet 312-103 (11/2022).

As is well known, Lazar is a physicist who claims he was hired in the late 1980s to reverse-engineer extraterrestrial technology near the famous Area 51. The Oomoans here seem to validate Lazar’s claims. And not only that. Some subsequent tweets make it quite clear that, as some ufologists have claimed over the years, many technological advances of our civilization come from extraterrestrial technology (see Figs. 11.4–11.6):

“Damaged devices were recovered. Others, operational, have been studied and tested. Many important technological advances in recent decades result directly from these studies. But you

do not have the notions of the underlying cosmo/bio physics to understand all functional aspects.”

“Alien devices, dating from Antiquity, located in Asia Minor, as well as the remains of a half-engulfed base in Antarctica, are supposed to relate to all humanity. From 1941, and so far, Germany, the US and the USSR/Russia, are the main protagonists of the trilateral acquaintance.”

“In 1936, an ancient and unintelligible artifact, discovered in Greece by a German explorer, proved to be emitting odd signals to the South Pole. Expeditions were mounted to find out the recipient of these pulses. In 1939, an artificial structure was located on aerial photographs.”

However, the Oomoans (and the *crop circles*; see Chapter 14 later) warn that any promised technological ‘gift’ is nothing but a trap (Fig. 11.7):

Question: *“I wonder if any of the amoral races have put some sort of restriction or similar so that humans cannot or do not manage to leave the planet on their own feet in ships.”*

Answer: *“This is clearly a big concern. By becoming consumers of advanced foreign technologies, you would depend on intricate key sub-components that you will never be able to reproduce, gradually forced, as a payment, to transfer property rights on your natural resources to Strangers.”*

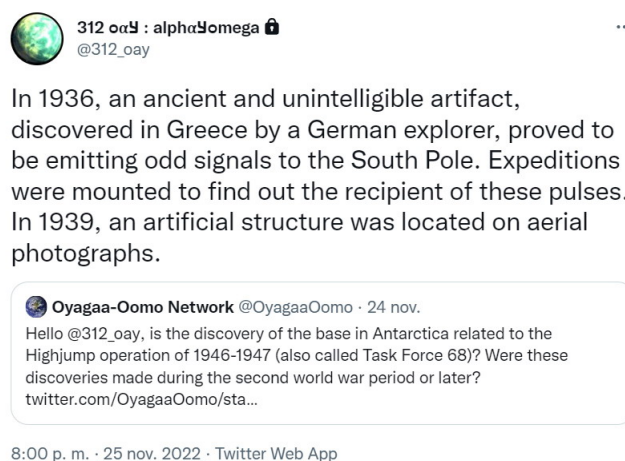


Figure 11.6: Tweet 312-105 (11/2022).

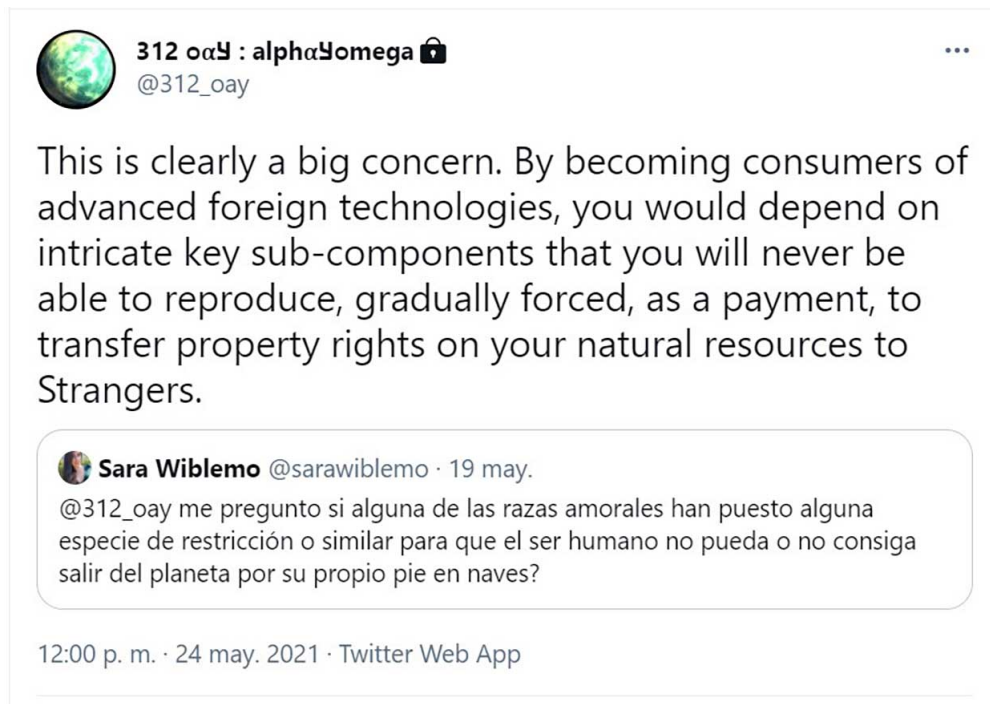


Figure 11.7: Tweet 312-68 (05/2021). Translation of the question in the text.

Chapter 12

Adverse consequences for Amoral/Hostile races

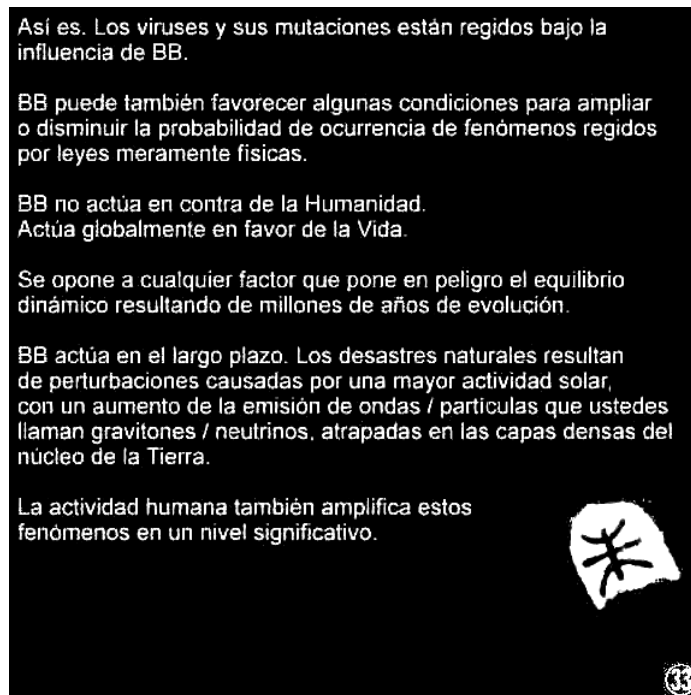


Figure 12.1: Part of Tweet O6-111 (12/2014).

In their first series of tweets, before disturbing details about unfriendly civilizations began to appear, the Oomoans provided general information on the possibility that a **BB (Planetary Collective Soul)** would take drastic measures against its own humanity if the paths that the latter followed attacked the flow of life. We group sentences from two tweets (Figs. 12.1 and 12.2):

“Viruses and their mutations are governed under the influence of BB. BB may also favor certain conditions to increase or decrease the probability of occurrence of phenomena governed by purely physical laws. BB does not act against Humanity. It acts globally for Life. It opposes any factor that endangers the dynamic equilibrium resulting from millions of years of evolution.”

“BB processes all the information available during this filter/conformation process. This information enriches BB’s general reactive mechanisms relating to the global evolution of the environment. Thus, a soul impregnated with the strong entropic charge of its destructive memories informs of the destructive potential of the entire human race, contrary to BB’s global action. Thus, an excessive entropic charge of the soul to be re-conformed can therefore lead, by a threshold effect, to a compensatory action of BB aimed at regulating this entropic potential. BB can then implement regulatory mechanisms directly directed against OEMMII who globally affect the homeostasis of the global ecosphere (...)”

Later on, the next exchange takes place (Fig. 12.3):

Twitter follower: *“When an ET treats another OEMMI race badly, is their BB affected, taking into account the rules in force in the cosmos?”*

Answer: *“BB [of the ET] is informed of their harmfulness. Just as with OEMMII cruel towards animals, mammals and OEMMII from their own ecosystem.”*

In other words, BB ‘reproves’ the immoral behavior of its humans, not only towards their fellows, but towards any human beings from other planets.

Another follower then argues:

“Don’t the amoral races know this? They’re supposed to know BB [see Chapter 6]. Not in depth? What about the hostile race?”

The answer (Fig. 12.4): *“They obviously do, suffering from genetic disorders and dying home planetary ecosystems. But they can still make up for it technologically.”*

This answer can only be described as astonishing. Amoral races suffer both genetic and planetary degenerations as a consequence of their behavior toward other humanities, and seem to be aware of it, yet they persist in their attitude as they are able to compensate for those effects (for now?)

A relation between *“dying home planetary ecosystems”* and the *“dying planet on which they could not continue to live from some point in the future,”* mentioned in the account reproduced in Chapter 11, thus seems likely. We will have the opportunity to see how the reactive action of BB has also affected the reptilians in Chapter 18.

Chapter 13

Men in Black (MIB) and cattle mutilations. 1966

Men in Black (MIB) are not a myth: they do (or did) exist. According to the Oomoans (see Fig. 13.1), they are the *“representatives of one of the races that interfere with your military authorities.”*

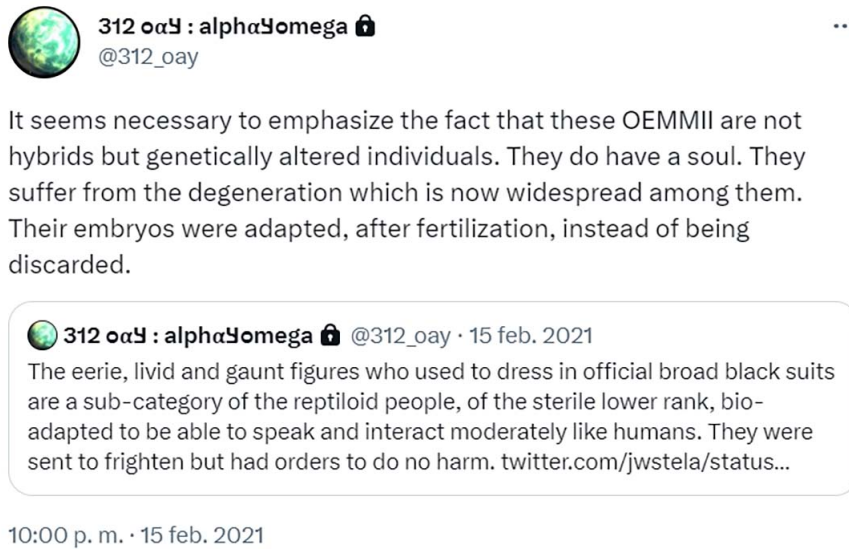


Figure 13.3: Tweet 312-39 (02/2021).

The information was completed with the two following tweets (Figs. 13.2 and 13.3):

“The eerie, livid and gaunt figures who used to dress in official broad black suits are a sub-category of the reptiloid people, of the sterile lower rank, bio-adapted to be able to speak and interact moderately like humans. They were sent to frighten but had orders to do no harm”.

“It seems necessary to emphasize the fact that these OEMMII are not hybrids but genetically altered individuals. They do have a soul. They suffer from the degeneration which is now widespread among them. Their embryos were adapted, after fertilization, instead of being discarded.”

Cattle mutilations are also real and are (or were) carried out by *“extraterrestrials” “with the help of military forces”* — see Fig. 13.1, right. (These episodes have occasionally been associated with the presence of helicopters and/or uniformed personnel without badges or insignia.) The purpose of such operations was clarified later (Fig. 13.4):

Question: *“Which amoral ethnic group is responsible for cattle mutilations? (...) Thank you.”*

Answer: *“Both sides [Grays and Orion], as requested, gave live demonstrations to U.S. Air Force officials to show how comparatively small gravitronic devices can lift heavy loads, focus as G-laser¹ beams to perform precise surgical skin cuts, or be used as weapons to remotely liquefy / vaporize soft tissue.”*

When asked whether the Oomoans stationed on our planet would be at physical risk if they were to confront individuals from amoral/hostile ET races, the answer was: *“Yes, in regard to the races (2) that interfere with your military powers.”* (Fig. 5.4, 2nd answer.)

Responding to another question from a follower surprised, by all logic, at the possibility that someone might have reached formal agreements with unknown ‘aliens’ — who do not even exist legally —, the Oomoans are succinct and blunt (Fig. 13.5): *“Armies can hire private contractors for security or technological matters. Licit contracts exist, since 1966.”*

Actually, a previous agreement had been signed in 1954 (Fig. 13.6):

“A first basic agreement with the Grays took place in 1954 but it was broken in 1964, at the insistence of Israel and the Vatican, when an Orion contingent landed with proofs of antecedence. A new deal was concluded in 1966, scheduled on a 120-year roadmap, involving both peoples.”

Chapter 14

Crop Circles, agreements, and warnings

Already in a French letter from 2003 (<http://www.ummo-sciences.org/fr/NR-17.htm>), the Oomoans clarified the origin of crop circles:

“You people are amazed at the crop circles that appear spontaneously in your fields. A large number of your brothers really believe that phonies provided with simple wooden boards could be at their origin. When will this naivety cease? Yes, these signs are mostly traced by OEMMII travelers foreign to your planet. We don’t make them ourselves but we know the OEMMII race that produces them. The morality of these OEMMII is high and we do not condemn their actions. Their aim (...) is to provoke a progressive awareness of the extraterrestrial reality through a legitimate questioning of the origin of these signs.”

As it happens, just a year earlier, in 2002, a truly unique crop circle had appeared in Crabwood, near the English city of Winchester and Chibolton. (Fig. 14.1.) It represented an ‘alien’ type face next to a disc with a series of points arranged in a spiral, as is the case of a CD or compact disc. This series of dots turned out to be the ASCII coding of the following text written in English:

Beware of Bearers of False Gifts
and of their Broken Promises
Much Pain but still Time
-BELIEVE-
There is good out there
We Oppose Deception
Conduit Closing
(bell sound)

In November 2015, a twitter follower asks the following question:

*“In response to a first series of questions , you replied: ‘Your elites mistakenly imagine that they will have priority in benefiting from the agreements with which their visitors seduce them’ [see Chapter 5]. Your response converges with the warning we received through Chibolton’s crop circle in 2001: ‘Beware of bearers of false gifts and their broken promises’. **Do you confirm***

that this is about denouncing the actions of the same ET species in relation to military Earth powers?

The answer of the Oomoans (Fig. 14.2):

"Yes."

To the question *"How to avoid a pact signed in our name?"* (14.3):

***"CHARTER OF THE UNITED NATIONS. CHAPTER 1. ARTICLE 12.
Invoke: threat to self-determination."***

The Oomoans have given some more details on the worrying possibility of signing agreements:

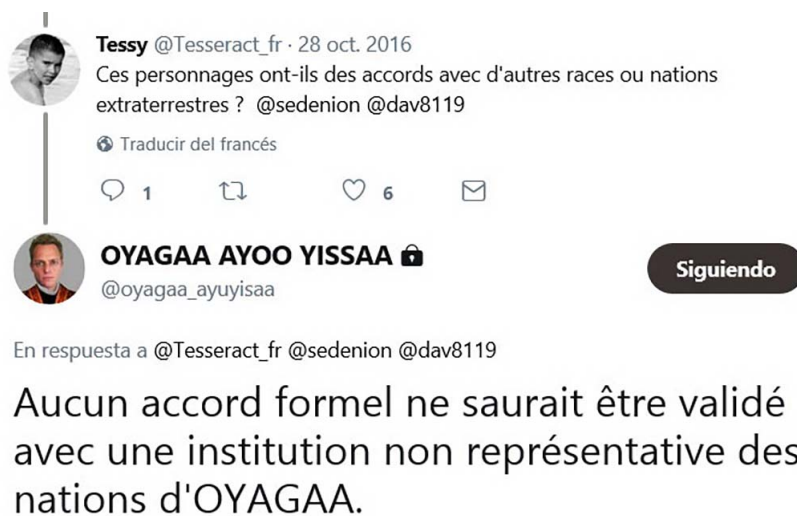


Figure 14.4: Tweet OAY-99 (10/2016). Question: *“Do these characters have agreements with other alien races or nations?”* Answer: *“No formal agreement can be validated with an institution that is not representative of the OYAGAA nations.”*

"No formal agreement with an institution not representative of the OYAGAA nations would be considered valid." (Fig. 14.4.)

List confirmed and fixed at 1967.”*

List confirmed and fixed... by whom? No answer.

What the Oomoans make quite clear is the fact that the amoral races, in order to facilitate the signing of that formal agreement, wish, or don't care about, a socio-economic collapse of the

planet Earth that would lead to the disappearance of nations in favor of a New World Order (NWM) controlled by members of the ‘Elite.’ These elite psychopaths are the very ones preparing the collapse after pushing, for decades, the well-known planetary ‘globalization’ process that, by now, has already increased outrageously the power of multinational corporations and the financial elite over countries and government, perpetrating step-by-step a true planetary coup d’état:

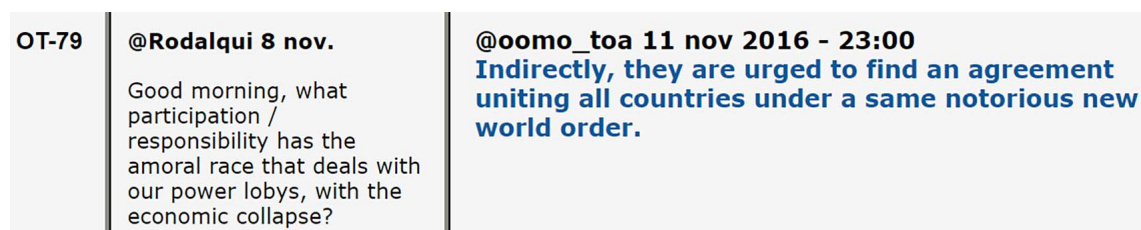


Figure 14.7: Tweet OT-79 (11/2020).

To the question: *“What participation / responsibility does the amoral race dealing with our lobbies of power have, in the economic collapse?”* the answer is (Fig. 14.7):

“Indirectly, they [the lobbies] are urged to find an agreement uniting all countries under a same notorious new world order.”

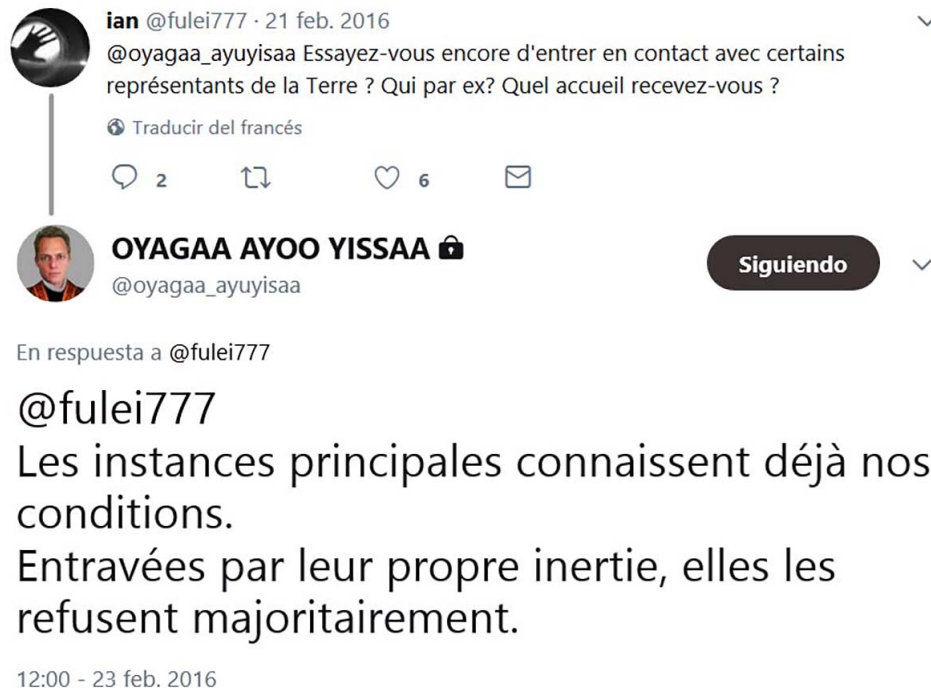


Figure 14.8: Tweet OAY-87 (02/2016). Question: “Are you still trying to make contact with certain representatives of Earth? Who, for example? What kind of reception do you get?” Answer: “The main instances already know our conditions. Hampered by their own inertia, the majority of them reject them.”

Regarding the agreement with the amoral aliens, the following exchange is worth noting (Fig. 14.8):

Question: *“Are you still trying to get in touch with certain representatives of the Earth? Who, for example? What reception do they have?”*

Answer: *“The main instances already know our conditions. Hampered by their own inertia, the majority of them reject them.”*

In the same vein, we have this later comment (Fig. 14.9):

Question: *“Would humanity succumbing to the amoral be considered a failure for you and other races? Thank you.”*

Answer: *“We have officially exposed our positions and warnings from 1954 to 1962 to representatives of the main UN countries, including Vatican City. We made it jointly with other peoples who share our ethical values. We can not compel you to accept our points of view and conditions.”*

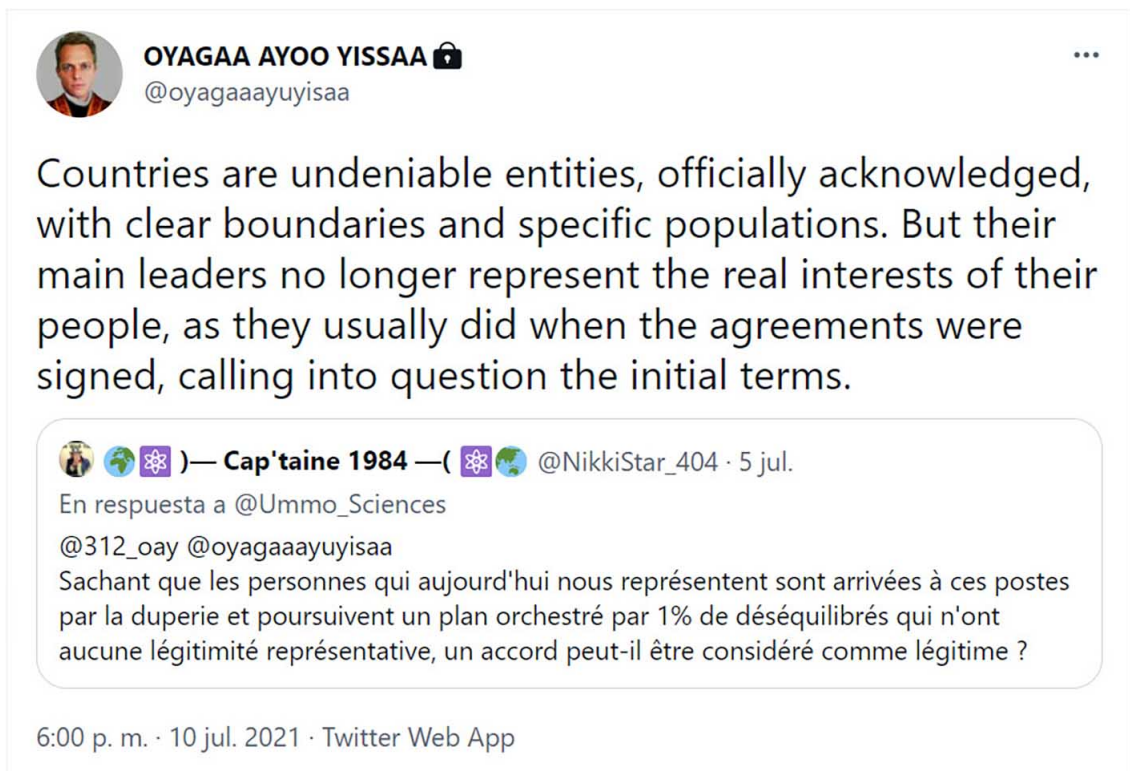


Figure 14.10: Tweet OAY-170 (07/2021). Question translated in the text.

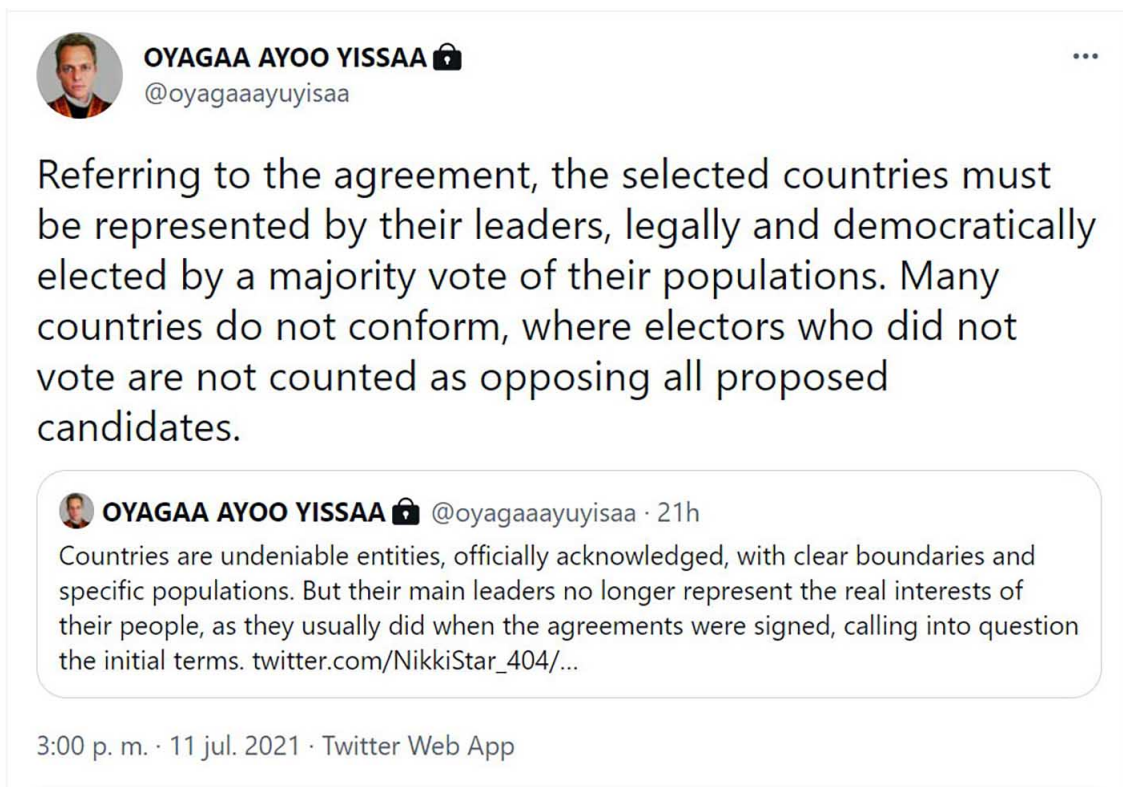


Figure 14.11: Tweet OAY-171 (07/2021).

Nevertheless, we have to mention two significant remarks made by the Oomoans regarding the validity of the list of countries shown in Fig. 14.5 (see Figs. 14.10, 14.11):

Question: “Knowing that the people who today represent us arrived at these positions by deception and are pursuing a plan orchestrated by 1% of unbalanced people who have no representative legitimacy, can an agreement be considered legitimate?”

Answer: “Countries are undeniable entities, officially acknowledged, with clear boundaries and specific populations. But their main **leaders no longer represent the real interests of their people**, as they usually did when the agreements were signed, **calling into question the initial terms.**”

“Referring to the agreement, the selected countries must be represented by their leaders, legally and democratically elected by a majority vote of their populations. Many countries do not conform, where electors who did not vote are not counted as opposing all proposed candidates.”

The relevance of these remarks — which are indeed true — is huge, but we ignore whether they are purely rhetorical or they will have any practical implications.

One follower asked about the role and knowledge of past and present high-ranked politicians. The reply makes it clear that they are nothing more than **puppets** (Fig. 14.12):

Question: “Almost 60 years have passed since 1962. How can we be sure the present political leaders are aware of your presence (for instance did Obama, Trump have proof of it? Biden?) and of your positions regarding Earth’s future?”

Answer: “Governance, on these very long-term topics, is deported to defense and intelligence organizations with more lasting and competent staff. Politicians are mainly dedicated to the legislative formalization of guidelines that were, for the most part, decided before their appointment.”

Chapter 15

SERPO

Among the most fantastic and improbable stories circulating about the relationship between the US military and extraterrestrials, the 'SERPO' case (Second *Eben Race Point of Origin*; Eben = *Extraterrestrial biological entity*) stands out. To the surprise of the followers, @312_oay, 'liked' a tweet (<https://twitter.com/CoronaDoller/status/1391396751626711042>) with a link to an interview with Len Kasten (not available on youtube anymore) where a 'Secret Journey to Planet Serpo' was addressed.

SERPO was supposed to be a "joint program of the US government and humanoids living on the planet Serpo, located in the star system of the Zeta Reticuli." While this is inaccurate, the Oomoans do validate the existence of SERPO (under Reptilian, not Gray, dominion) and the reality of some trips (see Figs. 15.1–15.4):

Question: *"Good morning @312_oay I read what I could find on SERPO (<http://serpo.org>). Can you tell us frankly if this top secret exchange program of twelve US military personnel to this planet of Zeta Reticuli really took place? Thank you."*

Answer: *"An exchange protocol was indeed agreed but few trips took place. The provided link contains a large majority of self-contradicting fictional accounts. The described colony, actually orbiting the HD 32923 binary star, is in no way linked to the visitors mentioned in the preamble."*

Question: *"Where were the participants in the SERPO project taken? It certainly doesn't look like they went to a main Grey system but instead to a second-class colonized planet. Could you give us some info? Thanks."*

Answer: *"The specific use by your officials of the term 'Point of Origin' indicates without a doubt that they are aware of the existence of a plurality of these points. This is an umbrella term. It does not refer to the exact homeland planet which is prohibited to all the other travelers."*

Question: *"As I understand your answer, the planet orbiting HD 32923 (SERPO) is a "colony" (a Rept colony I guess) but, nevertheless, you maintain on OOMO an embassy from that colonized planet. I clearly don't understand exopolitics."*

Answer: *"Your understanding is correct. This specific planet, the smallest we know among their many colonies, was artificially adapted long ago to deport people from their own home world,*

seized forcefully. This is their only colony allowed to deal with visitors and foreign diplomacy.”

Question: *“You have validated much of the visitor information provided by SALIANO. In the interview with Len Kasten that you just liked, he presents to us the race of the exchange as being distinct from the ‘Greys,’ but shorter in stature. Was it a collaborative race dominated by the Rept?”*

Answer: *“The inhabitants of this planet constitute a specific race. Their ancestors were the neighbors closest to the initial reptiloid world [IRW]. Both races teamed up peacefully for millennia until the wave of mass exodus, from a fully depleted IRW, that evicted almost all the natives [to SERPO].”*

The last answer highlights the low moral level of the Reptilians. Worse surprises await us in Chapter 18.

Chapter 16

Disclosure

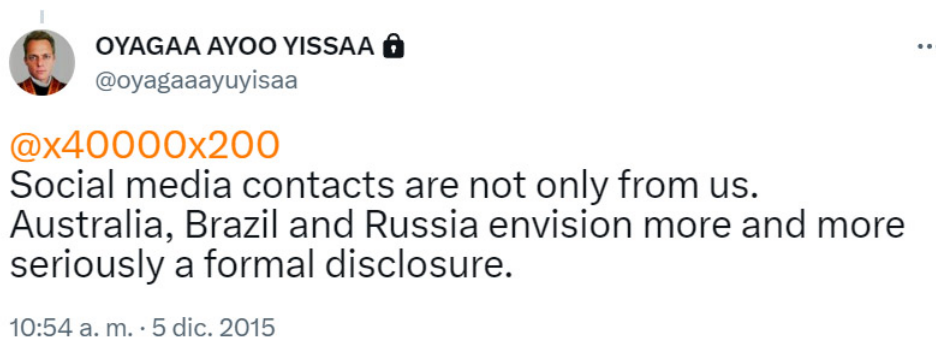


Figure 16.1: Tweet OAY-60 (12/2015).

Disclosure is understood as the official revelation of the existence of ETs and, in particular, of the contacts and pacts between them and the military powers. In response to the question: *“What % of the elite / secret services take seriously twitter contact? Attitude change since NR-18,”* they replied with this cryptic tweet (Fig. 16.1):

“Social Media contacts are not only from us. Australia, Brazil and Russia envision more and more seriously a formal disclosure.”

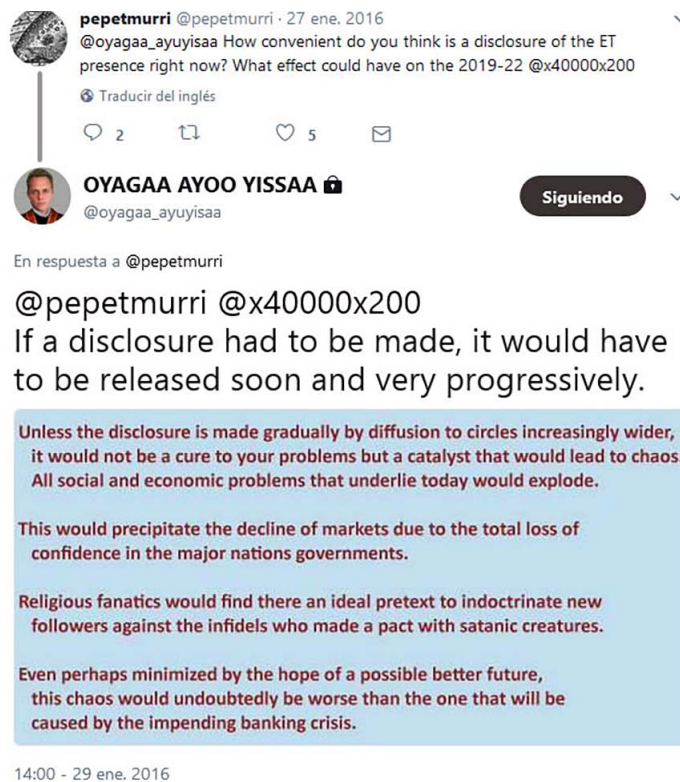


Figure 16.2: Tweet OAY-80 (01/2016).

Further information was provided in other tweets (Figs. 16.2 and 16.3): *“If a disclosure had to be made, it would have to be released soon and very progressively.”*

The previous text was accompanied by the following text in an image:

*“Unless disclosure is done gradually through dissemination to increasingly wider circles, it would not be a cure for your problems, but a catalyst that would lead to chaos.
All the basic social and economic problems of today would explode.
This would precipitate the collapse of markets due to a total loss of confidence in the governments of major nations.”*

Religious fanatics would find an ideal pretext to indoctrinate new followers against the infidels who made a pact with satanic creatures.

Even if downplayed by the hope of a possibly better future, this chaos would probably be worse than that which will be caused by the impending banking crisis.”

When asked as to how to make a “gradual” disclosure by means of “dissemination to increasingly wider circles,” the Oomoans’s answer was as follows:

*“Main intelligence agencies ↗ Ministry of
Defense & Presidency of the major nations
↘ state and territorial officers
↘ press
↘ people”*

In 2022 the Oomoans reported the following (Fig. 16.4):

Question: *“Hello, will the next two years see any operations from non-terrestrial civilizations, aiming to officially inform and contact our terrestrial populations of their presence, please?”*

Answer: *"An important meeting took place in 2016 between the military headquarters of major nations. A progressive disclosure protocol is already underway. It can be speeded up or slowed down depending on the events. A major announcement, scheduled for September 2019, had to be postponed."*

Note, by the way, the irritation of the Oomoans when they denounce fake news about 'official contact' by well-known charlatans from the ufological world (Fig. 16.5):

"It is truly shameful that credit can be given to such blatant ramblings. Official contacts have already taken place, several times in the past, with different foreign peoples and different earthly nations, separately or by small groups of common interests, including ourselves."

Recently (July 2023), the tweet shown in Fig. 16.3 has been updated so as to show the current state of affairs regarding the disclosure (see Fig. 16.6). It appears that the main intelligence agencies have *already* informed the ministries of defense and presidencies of the major nations, and the next steps are awaiting.

Chapter 17

Involvement of the 'Elite.' Deadlines

If many followers of the Ummo (Oomo) case had guesses about the identities of the members of the 0.1% pathocratic elite, the name of David Rockefeller was a safe bet. Sometimes nothing is what it seems, but at other times everything is exactly what it seems...

The sinister banker seemed to belong to what could be called the club of long-lived billionaires. Strikingly, a series of extraordinarily rich and powerful individuals who are widely recognized as psychopaths, criminals against humanity, war criminals, or all this together, tend to reach ages so advanced that one has the feeling that they are never going to die... In 2016, some media published the news that D. Rockefeller had successfully undergone his seventh heart transplant, at the age of 99. The news was quickly branded false and, of course, was never picked up by any 'serious' media (MSM). If it were true, Rockefeller's unprecedented feat would deserve to be included in the annals of medicine... of the Planet Earth.

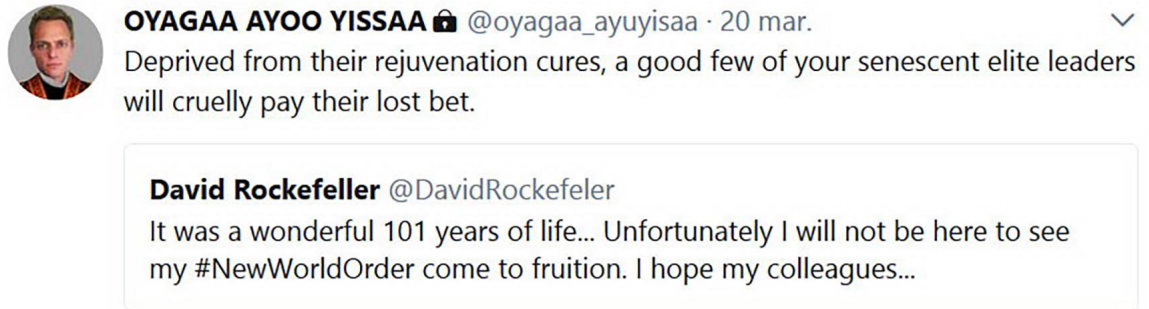


Figure 17.1: Tweet OAY-111 (03/2017).

Rockefeller died, however, on March 20, 2017, at the tender age of 101. That same day a tweet was published by @oyagaaayuyisaa with the following text (Fig. 17.1):

"Deprived from their rejuvenating cures, a good number of your senescent elite leaders will cruelly pay their lost bet."

This @oyagaaayuyisaa's tweet quoted another tweet (now deleted) from Rockefeller's own supposed (and little used) account, on which he, or someone in his name, had written, on the same day, March 20 at 10 a.m.: *"It was a wonderful 101 years of life. Unfortunately I won't be here to see my #NewWorldOrder come to fruition. I hope my colleagues... continue the good fight."*

Who provided these 'rejuvenation cures'? Suspicions become certainties after reading this tweet from 2021 (Fig. 17.2):

Question: *"Greetings, OAY. I have a question I feel you can answer if you would be so kind. Does the Elite or part of the Elite have meetings or meetings with any of the amoral races from time to time to assess progress?"*

Answer: *“Indeed. These meetings are held every 10 years, since the initial treaty was signed in 1966, to verify the progress on both sides. Do not doubt that the earthly part is the only one that is delayed in its achievements, leading to unfriendly penalties for some high-ranking elites.”*

It follows from the tweet that the latest meeting took place in 2016, and the next one will be in **2026**.

We have also learned that one of the ‘distinguished’ assistants to these sort of covens is the psychopath George Soros, thanks to this tweet liked by @oyagaaayuyisaa (Fig. 17.3):

“Does George Soros have or has he had any direct or indirect contact with ‘amoral’ beings?”

In this respect, it is also worth mentioning a singular news published in September 2015 in the web collective-evolution.com. This news must have been so interesting that @oyagaayuyisaa awarded a 'like' to a tweet quoting it one year and a half later, in March 2017. The 2015 headline was 'Why is Hillary Clinton talking to Laurence Rockefeller while holding a book on extraterrestrials?' In the news photo, Hillary Clinton holds in her arm a paperback book of which only a fragment of the black cover can be seen, upside down, displaying a blurred text in white letters. It is not possible to read the text in the photo, but the news editor, Arjun Walia, managed to identify the book without too much difficulty: It is 'Are We Alone?,' by the respected quantum physicist and university professor Paul Davies, who reflects on the ramifications of contact with intelligent aliens. See Fig. 17.4.

Although the 120-year treaty signed in 1966 concludes in 2086, time is rapidly running out: the year **2026** (in the midterm of the treaty) is critical, as it calls for the final signing of agreements.

Refer to these two worrying tweets (Figs. 17.5 and 17.6):

*“You would never accept that kind of full birth control, would you? However, the ongoing pact, which should be **definitively sealed before the end of July 2026**, implicitly involves this future for everyone on Earth:”*

“Approaching its midterm, the timetable of the treaty concluded with the Western military complex must hold the agreed conditions. Your visitors are now cutting their stealthiness threshold as the announcement of their presence is crucial to validate the good will of your nations.”

The first steps of the amoral race that obtains the Earth have also been defined (Fig. 17.7):

Question: *“Are the territories granted to the amoral by the 1966 contracts destined to be stripped of their resources?”*

Answer: *“Very important question. No. They no longer have the opportunity, nor the interest of looting your resources. They would install a new colony, led by a specific genetic family, first joining in the Earth governance, then, **gradually, extending their drastic legislation globally.**”*

At this point we absolutely need to know how much land would be granted to the visitors. The answer is in the following tweet (17.8):

"This man was probably aware of the roadmap's conditions. There is no direct injunction to downsize the human population. However, there is an imposed optimal ratio [1 visitor for 2000 inhabitants], and a contractual tenure of land [1 mi²] granted per visitor, which impose a trim."

This statement hints at an explanation for the goal of planetary depopulation that is systematically attributed to the 'elite' behind Agenda 2023 / New World Order...

The background image of the Twitter profile of @oyagaaayuyisaa was modified in April 2023 to show the image of two cigar-shaped ships showing on their surface a symbol (a kind of clover) that, as we shall see, could be associated with the Reptilians, although this is no longer so clear (see Section 20.7). Fig. 17.9. Note, in particular, the indication, on the left side, of the number of amoral colonizers (whether Reptilian or Grays) expected to populate the Earth in the coming decades. The specific '1/2000' ratio, along with a representative depiction of a human couple, was added even more recently (July 2023) to clearly remind the drastical conditions of the treaty to be signed.

The reason why we attribute the yellow clover to the Reptilians was given by the Oomoans in a

previous tweet; see Figs. 17.10 and 17.11:

“Aert de Gelder’s painting is confusing enough for the symbol appearing on the alleged spaceship. It is indeed one of the variants of the symbol - insignia - used by one of your visitors. Also, its off-center positioning is oddly correct, as if it were drawn by a direct witness.”

In the present context, we must think of an amoral civilization and, given the date of the painting (1710), it can only be the Reptilian one *if we maintain the hypothesis that the Grays did not arrive until the forties of the twentieth century*. However, as we have already mentioned, this hypothesis has been called into question more recently, as explained in Section 20.7.

To almost finish this chapter, we reproduce @oyagaaayuyisaa’s penultimate tweet as of the time of writing these lines. As we have seen in Chapter 14, the signing of the pacts requires the acquiescence of 24 specific nations (or those who control them). Unfortunately, it appears that, as of today, there is such unanimity. But there is no unanimity on which of the two amoral races to sign the pact with... Surprisingly, the current situation is a tie: 12 nations for the Grays (in green), and 12 for the Reptilians (in orange). The consequence is the following (Fig. 17.12):

“The current split, strictly balanced, could revoke the agreement. This would entail sharing the agreed territories and newcomers between both species. They would certainly refuse it. A dislocated country would be excluded from the voters, thus avoiding any possibility of balance.”

Recently, the link <https://babelia.libraryofbabel.info/imagebookmark2.cgi?Glyphs> appeared in the profile of the account @312_oay, leading to the ominous drawings shown in Fig. 17.13.

As it happens, only a few days before, a crop-circle with the same design appeared in the UK (<https://twitter.com/jaimemaussan1/status/1671170697819992065>).

Finally, the latest tweet published in @oyagaayuyisaa's account as of the time of this writing (July 19th, 2023) contains, again, a very serious warning about the pacts with any of the amoral races:

“Do NOT let THEM dispossess YOU for OTHERS.”

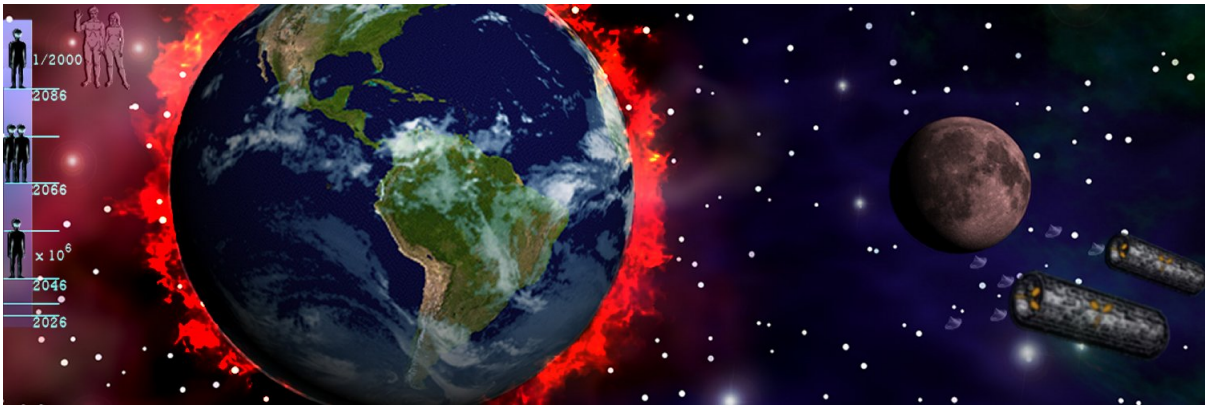


Figure 17.9: @oyagaaayuyisaa's background photo showing two obscure cigar-shaped ships heading to the Earth (right bottom). First published 04/2021, the ships have been *moved* at least twice so as to approach the Earth.

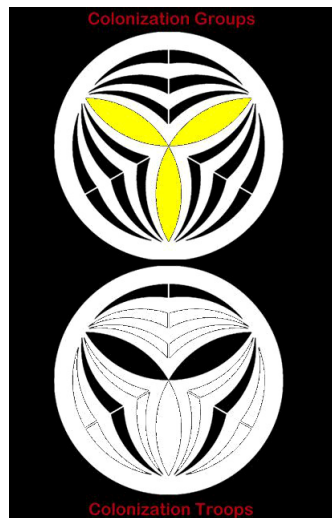


Figure 17.13: Drawings linked from @312_oay account. They seem to be variants of the Gray insignia mentioned above, visible in the cigar-shaped vessels of Fig. 17.9

Chapter 18

The presence of the Orion civilization in antiquity

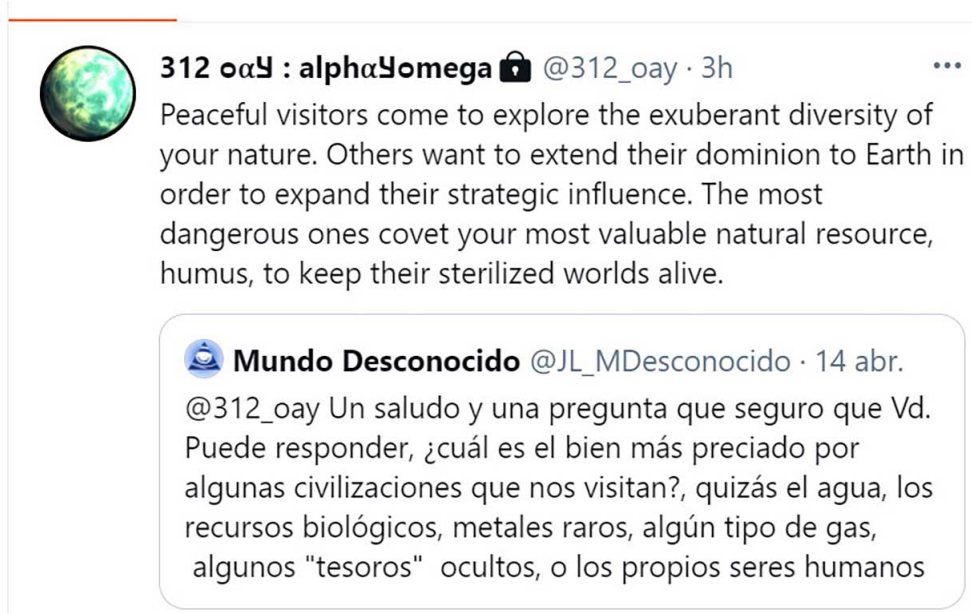


Figure 18.1: Tweet 312-58 (04/2021). Question translated in the text.

While the Grays are supposed to have been around since the 1940s, the Reptilians first arrived some 35,000 years ago, as we already saw. So, why are they *now* trying to colonize the Earth? What have they been doing all this time since that remote date? As we will see, the presence and activity of the reptilians has always been rather shadowy and sinister. Let us begin with the following tweet (Fig. 18.1):

Question: *“A greeting and a question that I am sure you can answer: What is the most precious good for some civilizations that visit us? Maybe water, biological resources, rare metals, some kind of gas, some hidden ‘treasures,’ or human beings themselves?”*

Answer: *“Peaceful visitors come to explore the exuberant diversity of your nature. Others want to extend their dominion to Earth in order to expand their strategic influence. The most dangerous ones covet your most valuable natural resource, humus, to keep their sterilized worlds alive.”*

The hostile civilization obviously corresponds to the last ones, while the Grays and the Reptilians belong, in principle, to the second category. A question followed immediately (Fig. 18.2):

Question: *“I ask myself 2 essential questions: 1) How do you transport billions of billions of billions of tons of humus across light-years? It would take countless automated trips by OAWOOLEAIDAA.”¹*

Answer: *“Time is indeed the only issue. Millions of tons of humus (and other resources) were slowly flushed out of the Earth around 13,200 to 12,700 years ago using countless single-use transport tanks, directly constructed on site excepting the energy source and the reactor confining it.”*

¹The already mentioned ‘OAWOOLEAIDAA,’ by which the ship is transferred to another space-time frame (another Universe) through which the distance is much shorter and in which the speed limit (the speed of light) is higher, seems to require an enormous amount of energy, increasing with the mass transported. It is not clear whether this procedure was used to transport the humus, or the ‘simple,’ but much longer, voyage across the ordinary universe was employed.

Details of the humus and water shipment are provided in the following two tweets (Figs. 18.3 and 18.4):

"The water and humus were collected together and sent in a single bundle. The water ice provided a protective shield for the spacecraft to absorb collisions with micro-debris encountered during the journey while humus was kept damp and nearly frozen inside this conservative shell."

"The containers were built horizontally, in polar regions, by gluing together annular slices of ice, each about 240 m in diameter and 40 m in external thickness, up to a length of 720 m. Humus was added at the end of the process, in separate lots according to the region of origin."

Question (Fig. 18.5): *"The timeframe discards the S [Saliano] race (if S are the 'hostile' and their arrival date was really in the 1940s) and leaves the rept as the only possibility (to our knowledge). Why was the plundering stopped? Did they get everything they needed, or did someone else stop them? Thanks."*

Answer: *"Additional resources from other worlds were needed to set up new colonies and fuel the ecosystem of their home planet. The looting of many fertile areas was stopped before reaching a point of no return that would have caused the needless ecological ruin of a potential new colony."*

At this point is necessary to emphasize that technologically advanced civilizations, as Ummo itself, have ultra-fast molecular duplication equipment that allows massive, exact copying of any structure or object.² Why do reptilians, and others, need to steal and transport humus (the basis, along with water, of supracellular organic life) instead of synthesizing it? One follower

posed this question and another suggested: *“I think their replicator machine can’t replicate life.”* The answer was (Fig. 18.6):

“This is perfectly correct. Replication occurs only at the molecular level. Life involves precise ionic balances that cannot be reproduced, the subatomic level remaining inaccessible. By copying a living being as perfectly as possible, you will only get its lifeless twin body.”

A terrible truth will now be revealed (Fig. 18.7):

Question: *“There’s something I don’t understand. If the Orion/Taurus visitors were the only foreigners on Earth at that time, why didn’t they just conquer the planet? It would have been really easy as there was no other alien opposition. Nobody would’ve noticed or cared about it.”*

Answer: *“They did conquer this planet, **killing most of the male population**, subjected to forced labor in unhealthy marshes. But they were also confronted with other races, on other planets.*

Faced with fast genetic degradation,³ they had to stop their invasions and repair the damage caused.

In order to reinforce the veracity of this atrocious fact, the Oomoans gave a 'like' to the following tweet and another similar one (Fig. 18.8): *"What happened 8,000 years ago when 1 man reproduced for every 17 women on average across the planet? Basically, a minority of men acting à la Genghis Khan reproduced w/ the vast majority of women in an expansive area shortly after the onset of agriculture."*

No much more information is available about the interaction of the Earthlings with the Reptilians over so many centuries. Indeed they seem to have played a role in many aspects of antiquity and must have connections in Sumeria, Egypt, the pyramids, etc.; but the Oomoans have only insinuated it while not giving precise information. At least we know that the Reptilians' performance as 'gods' leaves much to be desired (Fig. 18.9):

Question: *"Between Betelgeuse and Rigel 'Where Nephthys and Osiris join their hands, under the glance of Isis. To there sail the boats of the gods' [this is a quote of a previous enigmatic Ummite tweet] is in the red zone [actually it is in the orange (Orion + Taurus) zone]. We would have hoped they would be friendly gods. Do you have an explanation? Thanks."*

Answer: *"The ancient gods were not really depicted as paragons of mercy. On the contrary, most epics mention the wrath of the gods and the punishment of men who challenged their bans. Would a benevolent God test the obedience of the faithful by asking them to sacrifice*

their own children?"

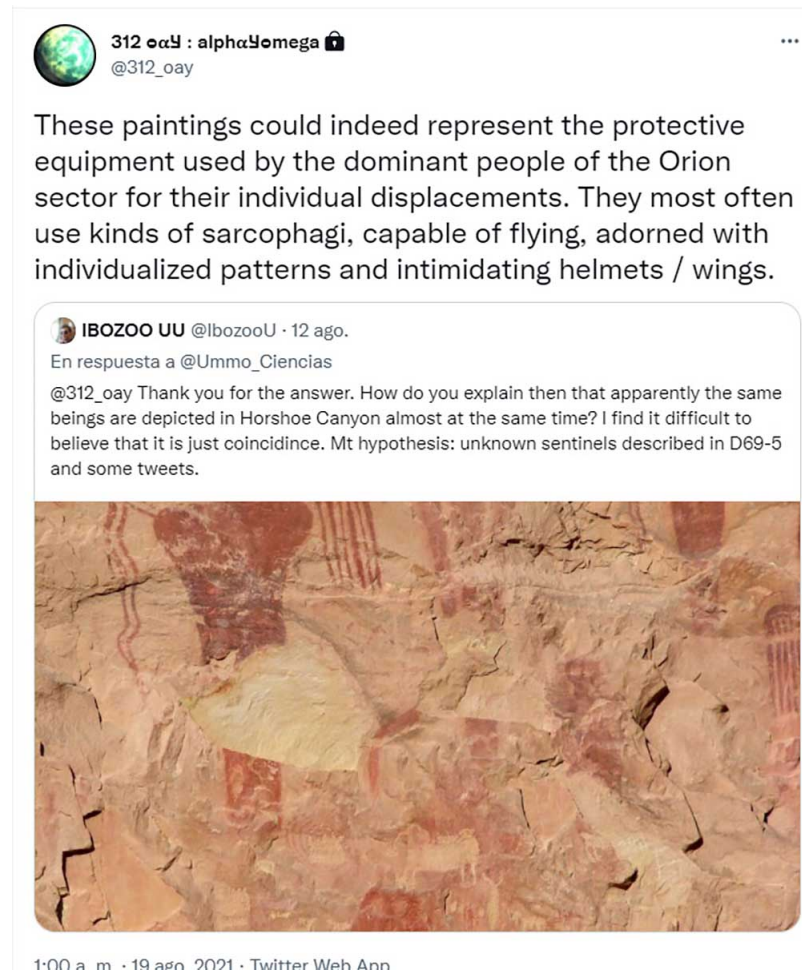


Figure 18.11: Tweet 312-86 (08/2021). Translation of the question in the text.

More references to the presence of Orion & Taurus (Figs. 18.10 and 18.11):

Question: *"Speculation: Orion/Taurus visitors could be those mentioned in oay-62-64-65, colonized by the Orion and today located on a planet around HD 32923 (104 Tauri), with which UMMO maintains diplomatic relations. The only Orion colony with this privilege."*

Answer: *"Several peoples, located mainly in these two particular constellations, are able to travel to you under the technological aegis of their supervisors. Some are vaguely evoked in your mythologies. They recorded their interactions with you as well as snippets of your civilization."*

Question: *"Thanks for the reply [he refers to another tweet], how then do you explain that apparently the same beings are depicted in Horseshoe Canyon at almost the same time? I find it hard to believe that it is just a coincidence. My hypothesis: the unknown sentinels described in D69-5 and some tweets."*

Answer: *"These paintings could indeed represent the protective equipment used by the dominant people of the Orion sector for their individual displacements. They most often use kinds of sarcophagi, capable of flying, adorned with individualized patterns and intimidating helmets / wings."*




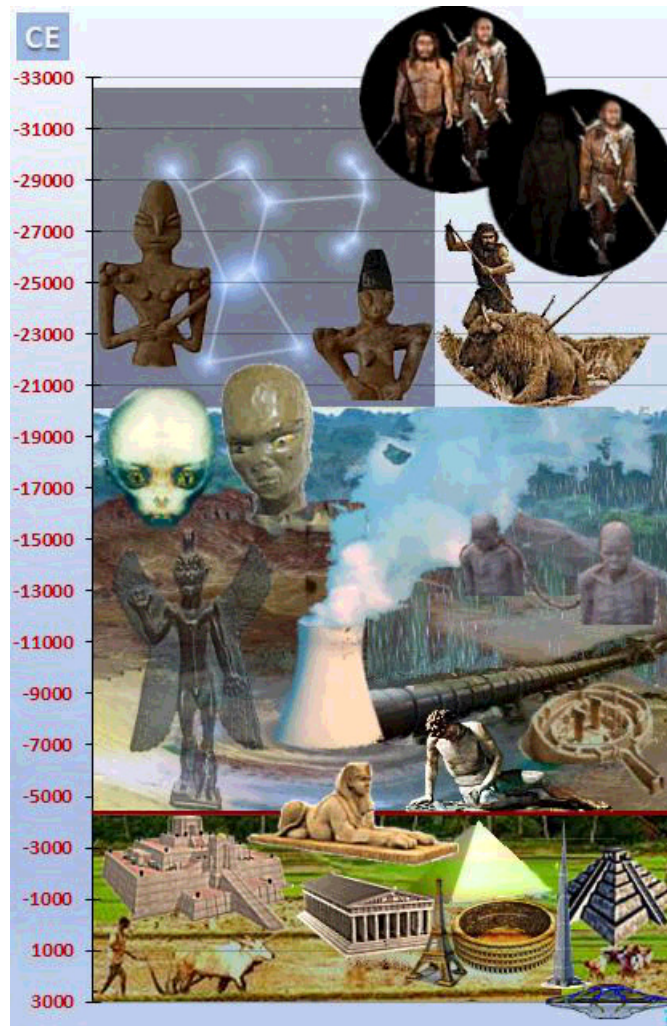


Figure 18.12: From @312_oay. August 2021.

Chapter 19

Anex. David Icke and Marshall Vian Summers

Very succinctly, we will review some sources that — in fact, previously — have disclosed information very similar, at least in certain aspects, to that provided by the Oomoans in their last series of letters and their tweets. This information has been explicitly validated by them, at least substantially and/or partly.

David Icke appears in the series of GR1 letters — to the astonishment of the addressees — almost from the very beginning. It is revealed that Icke is an 'OEMMI OUXI BIIAEII' (a new expression), and he becomes, *de facto*, a kind of main narrative thread for the new and transcendental revelations that, little by little, first in the letters and later in the tweets, will be made in this new (and critical) contact phase. In short, David Icke is a sort of modern 'prophet' who receives far-reaching privileged information from BB about the state of our humanity, even if not everything he receives is sufficiently clear and/or correctly interpreted. We select some important mentions about him:

"[w]e beg you to read or listen to, on your XAANMOOAYUBAA [computer, internet], your brother David Icke, who according to our verifications is an OEMMI OUXI BIIAEII."

"You have (in general) despised the personality and behavior of DI. You have looked at the finger pointing to the moon."

*"It is true that DI has stuffed the matter with metaphors. There has been no chromosomal hybridization between your leaders and the 'reptilians' (who **EXIST** and we called differently in past reports, in which we already added that they do not deserve our respect in any way because they intend to organize the future of OYAGAA in a morally repulsive way)."*

[Here the typographical emphasis is on the original text.]

"[Y]our brother DI, although of a special nature, is practically the same as all of you. You should not therefore attribute to him a non-existent thaumaturgical perfection. You must admit that he makes mistakes and he fabulates like the vast majority of you. (...) Take what is ethical in

the words of DI, and forget other fantasies or lucubrations in which your brother engages with some frequency.”

Much later, in response to a question about the nature of the OEMMI OUXI BIIAEII, the Oomoans finally give a short definition in a tweet (Fig. 19.1):

Question: *“Hello. We really need to know what we should understand from the expression OEMMI OUXI BIIAEII. Thank you very much.”*

Answer: *“OEMMI [person] suffering from supraliminal tuning on the NIA.OUXOO¹ channel. Exacerbation of the BB instructions. Raw Perception of the Social Network.”*

Marshall Vian Summers is a ‘contactee/channeler’ who claims having spent hundreds of hours, since the 1980s, hearing in his head a neat and clear voice from beings who call themselves ‘*The Allies of Humanity*,’ and allegedly are advanced ethical ETs concerned about the fate of our humanity. The core issue around which Summers’ messages revolve in his extensive literary production (on the Internet and on paper book) is a set of dramatic and repeated warnings from the ‘Allies’ against the so-called ‘Intervention,’ which turn out to be extraordinarily similar to those made by the Oomoans regarding the amoral races.

“[T]hey do not consider you to be their equals. They do not value your religions, your cultures or your customs. They see you primarily as one of the resources of the world. As such, they seek to take advantage of you in all the ways that they can.”

“They view you much the same way that you view domesticated animals that you use as a resource.”

Compare with the already mentioned Ummo tweet of October 2017:

“Both would alike turn your descendants into unemotional healthy bodies, mere AAGAOEMII [domesticated men] legally hired by godlike masters for futile rewards.”

More:

“Do not deceive yourself in thinking that they are drawn to your spirituality because they lack such things themselves. This would be a foolish and perhaps fatal mistake.”

“All natural curiosity has been bred out of them and very little remains. There is, in fact, very little of what you would call ‘Spirit’ (...) They are controlled and controlling and follow patterns of thinking and behavior that are firmly established and strictly reinforced.”

Compare with the Ummo tweet of December 2014:

“they act like ants”

More:

“They might seem to empathize with your ideas, but it is only to gain your allegiance.” “[T]hey do not consider you to be their equals. They do not value your religions, your cultures or your customs. They see you primarily as one of the resources of the world. As such, they seek to take advantage of you in all the ways that they can.”

“They view you much the sameElon way that you view domesticated animals that you use as a resource.”

“The visitors (...) will say they are here to save humanity from itself, that only they can offer the great hope that humanity cannot provide for itself, that only they can establish true order and harmony in the world. But this order and this harmony will be theirs, not yours. And the freedom that they promise will not be yours to enjoy.”

“They do not value diversity in cultures; they certainly do not value it within their own cultures. Therefore, they will attempt to eradicate it.”

“They recognize that to gain human allegiance, which is their goal, they must present themselves as capable of assisting and even saving humanity from its own problems. (...) Yet this all represents deception, for the Collectives actually seek to increase human conflict, to weaken the strongest worldly powers and to gain allegiance through human failure-allegiance and a reliance upon their presence.”

The Oomoans must have felt as astonished just like the twitter follower who noticed the similarities between the speech of the ‘Allies’ and that of the Oomoans, when they had to answer him like this:²

“We are surprised at this message. We support it, but cannot guarantee its source.”

24 days later, they publish:

“We have identified the origin of these messages. We can only partially validate them, and we don’t wish to interfere.”

Regarding the voices that so impressed Marshall Vian Summers, the Oomoans clarify:

“In this case, the transmission was osteophonic through an organometallic maxillary implant to amplify vibrations.”

There seem to be no vicious intentions in the authors:

“In this case, it is neither mental manipulation nor subliminal information infused from BB.”

Regarding the sincerity of the receiver and the fidelity of the transcripts of his messages:

“Verified until 2/1998. 2 sources. Information extrapolated / interpreted. Not validated after 8/1999.”

In other words, the contactee seems to have added some elaboration of his own to some extent.

The intriguing existence of “2 sources” (acting on Summers) has not been clarified by the Oomoans.

WARNING

The identifier (username or handler) of a twitter account (@...) is unique, but the name of the account is not. One or two apocryphal accounts that imitated the design of the original Ummite twitter accounts — using the same chosen name, same header image, same profile image, same color scheme, etc. — appeared in the past. As time passed, new false accounts arose. The appearance of the first apocryphal account led the genuine @oyagaa_ayuyisaa and @oomo_toa accounts to change their original profile image, which had been, in both cases, one of the 1967 photographs of the famous San José de Valderas flying saucer. (Recall, by the way, that a profile image change automatically applies to all tweets previously published in the account.) There have been other occasional changes in the header image and the color scheme of the @oyagaa_ayuyisaa and @oomo_toa accounts, as well as the appearance and disappearance of various descriptions texts in the profiles.

In short, we need to warn of the presence or eventual appearance of false accounts. We stress that the only validated accounts are @oaxiboo6, @oolga_waam, @oomo_toa and @oyagaayuyisaa (previously named @oyagaa_ayuyisaa, as indicated); the latter is the only active old account at this time, along with the new @312_oay.



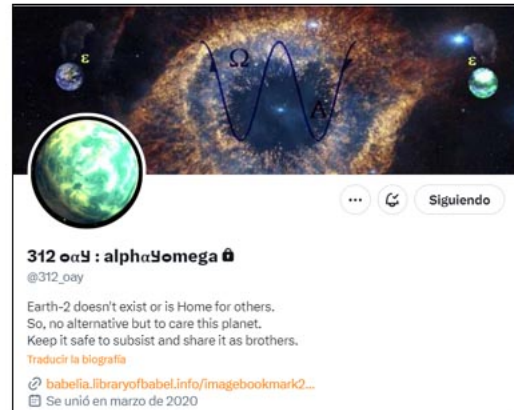

Chapter 20

ADDENDA

20.1 “Arriving”

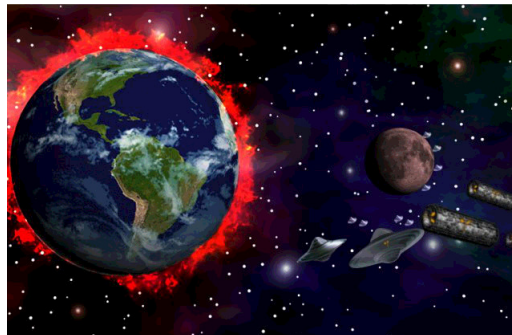


Figure 20.1: “LLEGANDO” (“ARRIVING”). Fig. presented by @312_oay at the end of July 2023.

On July 26, 2026, the account @312_oay published a new image that reproduces, with a slightly different framing, the background image of the @oyagaaayuyisaa account, but with several disks or ‘flying saucers’ perfectly visible accompanying the cigar-shaped ships and also clearly showing the symbol of the ‘clover’. It is also seen how a ‘flock’ of these craft is headed for or is already on the dark side of the moon. The image has the disturbing title “ARRIVING” (in Spanish, “LLEGANDO”.) See Fig. 20.1.

20.2 Jaime Maussan

The popular Mexican ufologist Jaime Maussan has been enthusiastic about the process of apparent ‘disclosure’ underway, which has reached its climax, for the moment, with the recent declarations of several governmental/military witnesses before the U.S. Congress. Maussan published in a tweet on July 28, 2023: *“Special message: We must unite as humanity; we owe it*

to those who have not been born, consider yourself fortunate to have lived this disclosure". The next day he gets this response, tweet OAY-183 (Fig. 20.2):

"Dear Sir. We admire your yearnings for the future of the unborn. They should also have been the goal of the United Nations instead of sealing pacts signed in secret six decades ago. The world will end up united, yes, but populated by a dispirited humanity."

20.3 Tie-breaker

Unfortunately, the standoff between Greys and Reptilians mentioned in Chapter 17 (Fig. 17.12), which could dynamite the agreement, has vanished. Ukraine, already considered a “dislocated country,” has been erased from the list of voters, which remains at 23 and thus makes a tie impossible.

In fact, as can be seen from the map in tweet OAY-184 (Fig. 20.3), the original number of countries must have been 25 (so that a blocking situation was not foreseeable), but Yugoslavia was excluded, no doubt for the same reason that Ukraine has now been excluded — both are shown in red. It so happens, moreover, that Ethiopia, which in Fig. 17.12 appeared on the NATO side (pro-Reptilians), has turned to the BRICS side — it has very recently moved closer to Russia —, so that the Grays now have 13 votes and the Reptilians 10.

Tweet OAY-184: *“The possibility of a loophole, resulting from an exact balance of declared allegiances, was not an option at the very beginning of the agreements. However, even with the*

recent sharp change in the historical majority, this unlikely situation now seems to have to be ruled out."

Later, on September 15, 2024, OAY posts the following tweet (Fig. 20.4):

Tweet OAY-197: "As wars blind the peoples of the Earth, strategic geopolitical choices and alliances are slowly evolving towards a situation that is probably almost definitive. Promoting wars was a bad strategy for the Western bloc while the adversaries were quietly organizing a solid concordat."

The supports are still in favor of the Grays by 13-10.

20.4 Orion Historical Archives

In relation to the circumstances expressed in the previous section, the following exchange occurs (Fig. 20.5):

Question: *"So why are Orion's visitors rejected in favor of others?"*

Answer (which does not clearly answer the question posed):

"These visitors have provided historical records of their visits over the millennia. Some are damning for religious authorities, self-proclaimed receptacles of Divine Truth.

An agreement would imply that these compromising archives remain hidden under the seal of absolute secrecy."

There follows another exchange in which the question asked is also addressed only very tangentially (Fig. 20.6):

Question: *"Does this mean that if a single ethnic group were to control the Earth, the archives would be revealed, putting an end to the papacy and the myths surrounding Christianity? What about other religions?"*

Answer:

"Although records of Jesus are lacking, the same is not true of the figures of Abraham and Moses. They appear clearly identifiable with, for Abraham, a context totally discrepant from that of the Scriptures.

With regard to Moses, on the other hand, the parallelism is indisputable."

20.5 More about the treaties. History of the Reptilians vs. the Grays

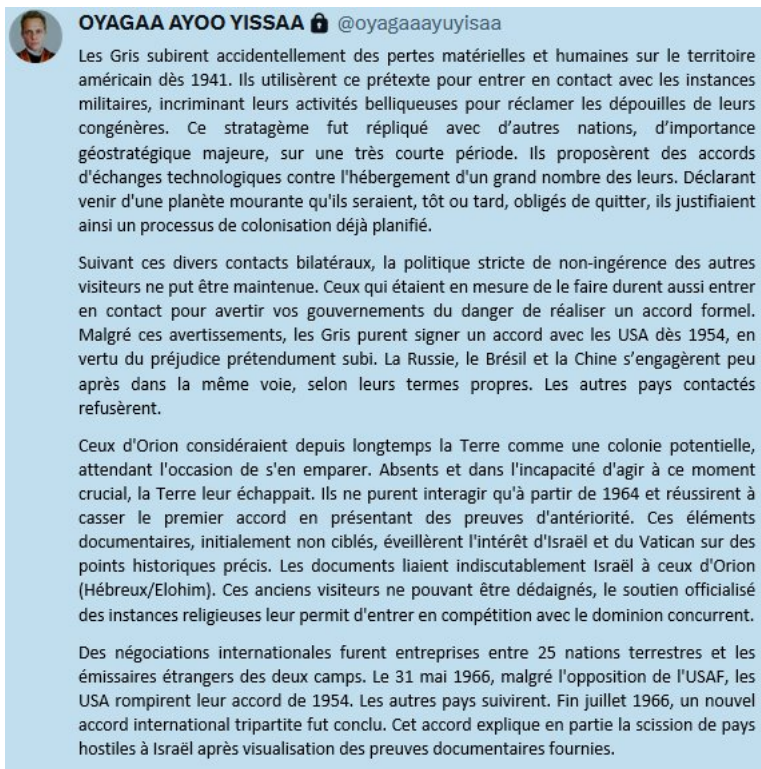


Figure 20.7: Tweet OAY-185 (08/2023). Translation in the text.

On August 30, 2023, the account @oyagaaayuyisaa publishes a tweet in which it nuances and completes a report written by a follower about the historical vicissitudes of the contacts and treaties between Grays, first, and Orion (Reptilians), later, with various nations on Earth. See Fig. 20.7.

"The Grays accidentally suffered material and human losses on U.S. territory as early as 1941.

They used this as a pretext to contact the military authorities, incriminating them for their war activities in order to claim the remains of their fellow humans. This stratagem was repeated with other nations of great geostrategic importance, in a very short time. They offered technological exchange agreements in exchange for hosting a large number of their own. Claiming to come from a dying planet that sooner or later they would be forced to abandon, they justified an already planned colonization process.

"After these various bilateral contacts, the strict policy of non-interference by other visitors could not be maintained. Those who were in a position to do so also had to make contact to warn your governments of the danger of entering into a formal agreement. Despite these warnings, the Greys were able to sign an agreement with the U.S. as early as 1954, by virtue of the damages allegedly suffered. Russia, Brazil and China soon followed suit, on their own terms. The other contacted countries refused.

"Those from Orion had long regarded Earth as a potential colony, waiting for the opportunity to take it over. Absent and unable to act at that crucial moment, Earth eluded them. It was not until 1964 that they were able to interact, and managed to break the first agreement by presenting evidence of precedence. This documentary evidence, initially scattered, aroused the interest of Israel and the Vatican on specific historical points. The documents indisputably linked Israel to those of Orion (Hebrews/Elohim). These ancient visitors could not be disdained, and official support from religious authorities enabled them to enter into competition with the rival domain.

"International negotiations were engaged between 25 Earth nations and foreign emissaries from both sides. On May 31, 1966, despite USAF opposition, the United States broke its 1954 agreement. The other countries followed suit. At the end of July 1966, a new tripartite international agreement was concluded. This agreement partly explains the split among countries hostile to Israel after seeing the documentary evidence provided."

It seems to be deduced from the above text, among other things, that the "dying planet" status attributed by the Greys to their original planet is essentially false. And, most probably, they would make a point of not explaining to their terrestrial interlocutors that their civilization already 'possesses' a whole handful of colonized planets at its total disposition...

In November 2024, tweet OAY-200 provides the following complement of information (Fig. 20.8):

"The pact between the USA/USAF and the Greys was called into question in 1964, when the Orion Overlords landed with their own ship. It really ended on May 31, 1966, when the USA ratified the new agreement. Some USAF officers suffered strange heart attacks or strokes that same day."

20.6 Cape Girardeu before Roswell

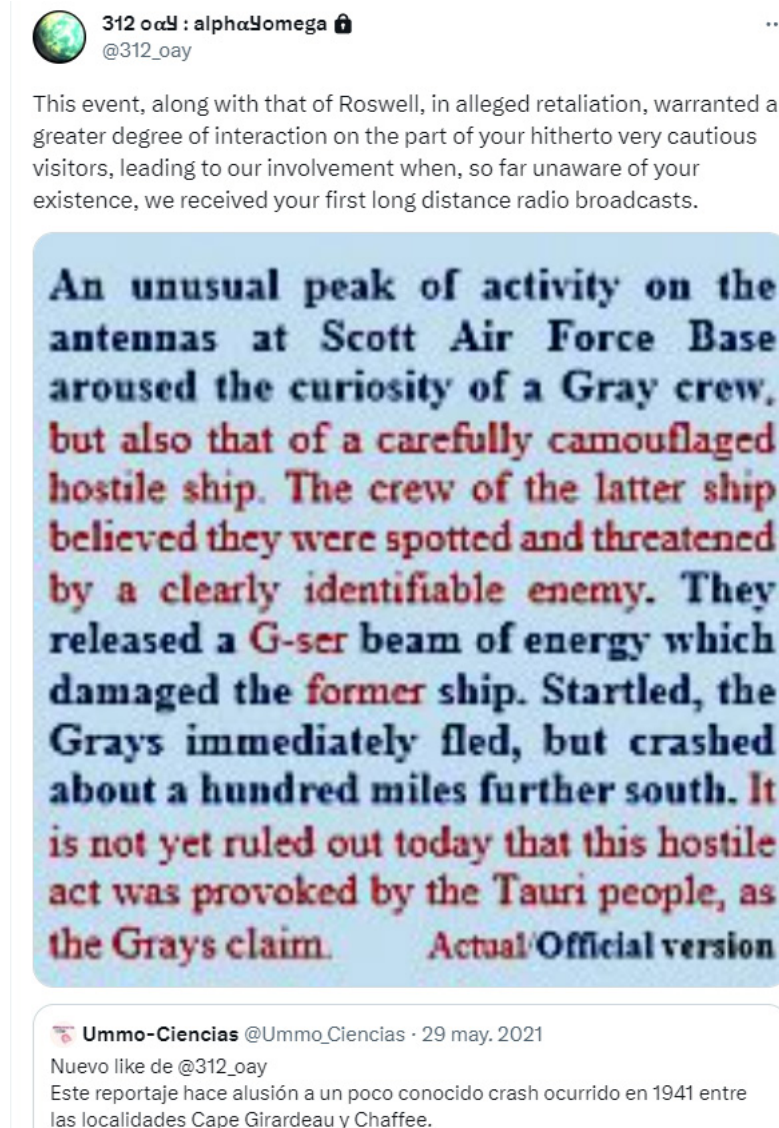


Figure 20.9: Tweet 312-114 (09/2023).

In September 2023, @312_oay publishes information about the alleged crash of a spacecraft near Cape Girardeau, USA, in 1941. He does so by completing — in red — a text about the incident — in blue—, previously published by ufological researchers (see Fig. 20.9).

This event, together with that of Roswell, in supposed retaliation, warranted a greater degree of interaction on the part of your hitherto very cautious visitors, leading to our involvement when, so far unaware of your existence, we received your first long-distance radio emissions.

* * *

An unusual peak of activity on the antennas at Scott Air Force Base aroused the curiosity of a Gray crew, but also that of a carefully camouflaged hostile ship. The crew of the latter ship believed they were spotted and threatened by a clearly identifiable enemy. They released a G-ser beam of energy¹ which damaged the former ship. Startled, the Grays immediately fled, but crashed about a hundred miles further south. It is not yet ruled out today that this hostile act was provoked by the Tauri people, as the Grays claim.

20.7 The Orion symbol... and Elon Musk

The aliens shown in the upper left of Fig. 17.9 have an undoubted resemblance to the 'Grays,' all the more so if their depicted height is in proportion to that of the two humans drawn there. But, if so, this would mean two things: (a) the Oomoans already know that the Grays have unseated the Reptilians — the most likely outcome given the current vote distribution, on the other hand, but not yet consummated; (b) the discoidal and cigar-shaped ships in the image should belong to the Grays. Finally, the yellow clover symbol of such ships should then be ascribed to the Grays, not to Orion. But then, if we remember that a disk with that symbol was already depicted by a painter in 1710, it follows that the Grays were already here at that date and did not arrive for the first time in the mid-20th century, contrary to what seems to be deduced from the letter NR-23, mentioned above...

The premise that the aliens in the drawing in Fig. 17.9 are Grays has been confirmed by an OAY 'like,' from September 2020, given to a tweet by @pepetmurri in which the latter dismisses such aliens as a 'generic representation': *"Not so generic, in my opinion, because the size of those visitors, around 4 feet, is given."*

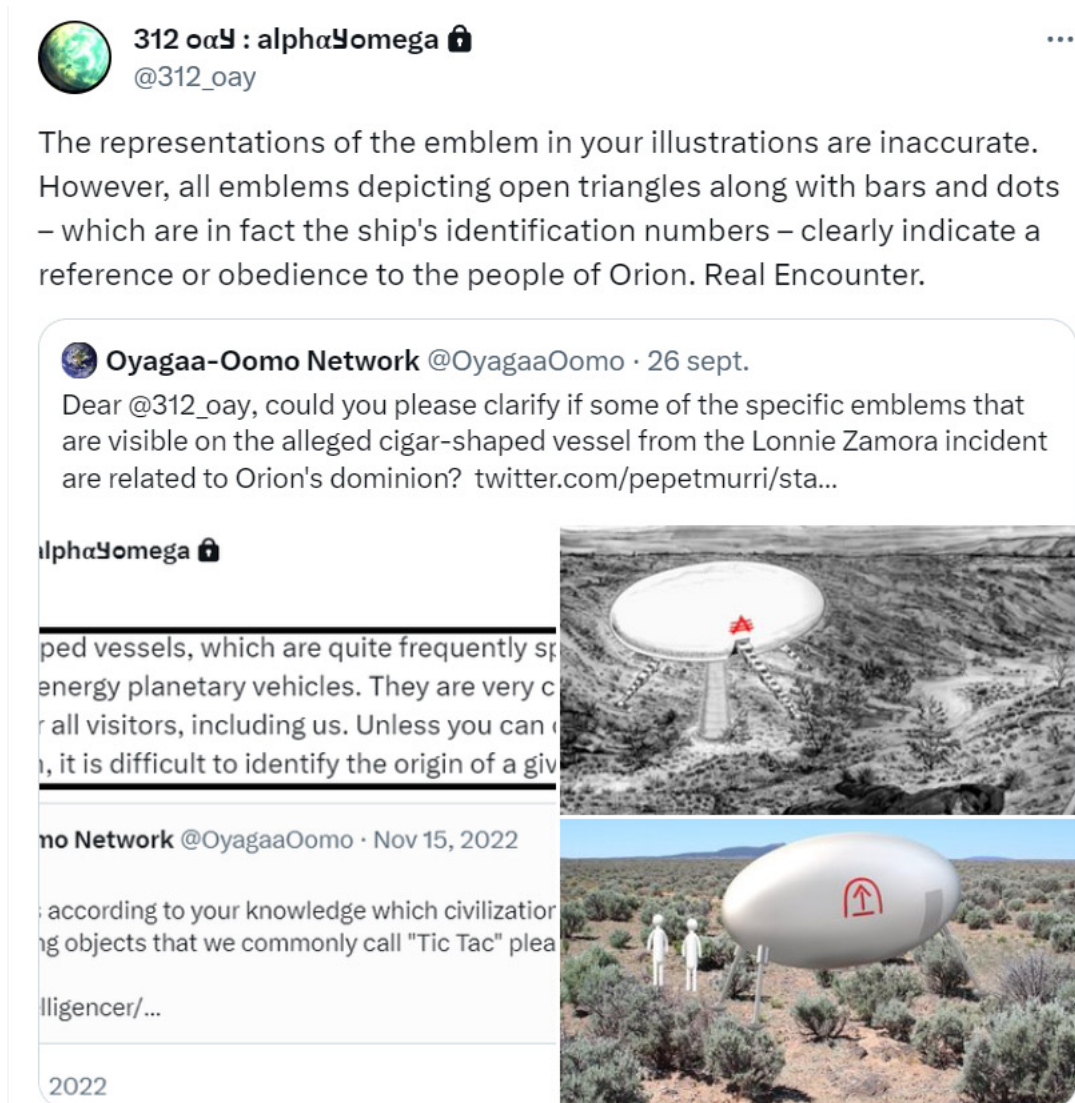


Figure 20.10: Tweet 312-15 (09/2023) about the incident of police officer Lonnie Zamora near Socorro, USA, in 1964.

In turn, the hypothesis that the clover is the symbol of Orion has been strongly weakened because the Oomoans have stated, in tweet 312-315, late September 2023, that the insignia of the Orion ships is an open triangle (see Fig. 20.10):²

“The representations of the emblem in your illustrations are inaccurate. However, all emblems depicting open triangles along with bars and dots – which are in fact the ship’s identification numbers – clearly indicate a reference or obedience to the people of Orion. Real Encounter.”

What seems to be the correct form of the emblem mentioned in the previous tweet appears in the illustration of the next tweet received from @312_oay, very shortly thereafter (Fig. 20.11). This surprising tweet, on the other hand, answers in a cryptic way to statements by Elon Musk (who appears not for the first time in the dossier) in which the latter assures that he personally has no proof of the existence of aliens on Earth. Written as an alexandrine quatrain, the tweet reads:

*“Remembering that day? That day of ones and fives
when you went all the way, to the fifteenth degree.
Remembering this too, in the heat of the hives?
Your guess: not forty-two. Could it be forty-three?”*

20.8 Physical appearance of the Taurians and Orions ('reptilians')

According to a tweet dated October 2023, the appearance of Taurus visitors is as follows (Fig. 20.12):

"The Tauri people, with whom we have dialogue relationships, are often confused with the Grays due to their little size and relatively large heads and eyes. However, they look more like small, macrocephalic Asians with strangely wide eyes. Their complexion is a pale greenish khaki."

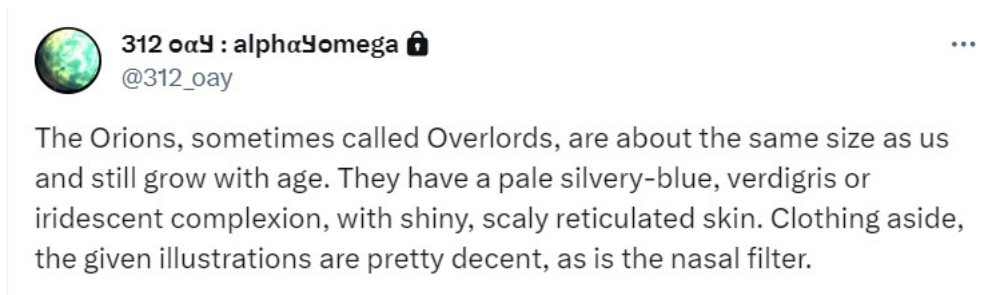


Figure 20.15: Tweet 312-118 (11/2023).

On November 4, 2023, a new link appeared on @312_oay's account profile leading to a relatively lengthy explanation of the scheme in Fig. 18.12. This explanation is divided into 4 parts, each one in an image-text:

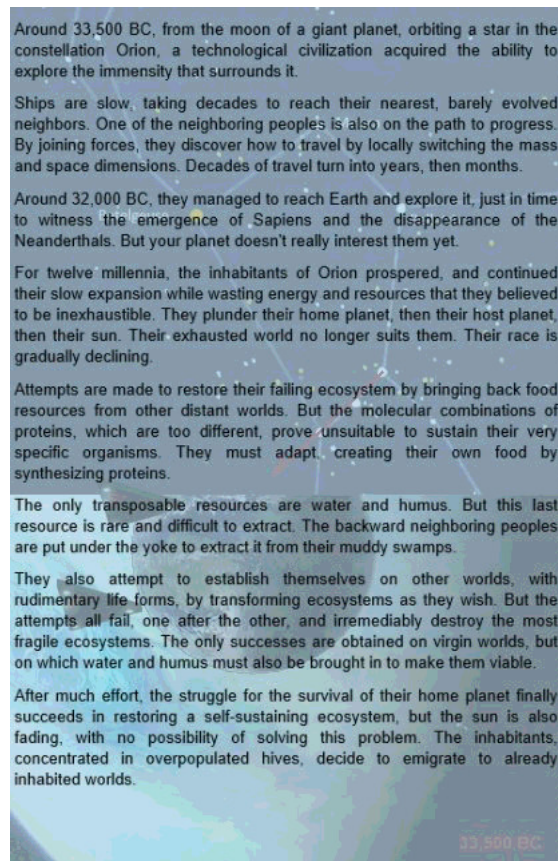


Figure 20.16: First text part of the 'Oritau' report (11/2023). Notice the triangular ships in the background picture.

FIRST PART (Fig. 20.16):

Around 33,500 BC, from the moon of a giant planet orbiting a star in the constellation Orion, a technological civilization acquired the ability to explore the immensity that surrounds it.

Ships are slow and take decades to reach their nearest, barely evolved neighbors. One of the neighboring peoples is also on the path to progress. By joining forces, they discover how to travel by locally switching the mass and space dimensions. Decades of travel turn into years, then months.

Around 32,000 BC, they managed to reach Earth and explore it, just in time to witness the emergence of Sapiens and the disappearance of the Neanderthals. But your planet doesn't really interest them yet.

For twelve millennia, the inhabitants of Orion prospered and continued their slow expansion while wasting energy and resources that they believed to be inexhaustible. They plunder their home planet, then their sun. Their exhausted world no longer suits them. Their race is gradually declining.

Attempts are made to restore their failing ecosystem by bringing back food resources from other distant worlds. But the molecular combinations of proteins, which are too different, prove unsuitable to sustain their very specific organisms. They must adapt, creating their own food by synthesizing proteins.

The only transposable resources are water and humus. But this last resource is rare and difficult to extract. The backward neighboring peoples are put under the yoke to extract it from their

muddy swamps.

They also attempt to establish themselves on other worlds, with rudimentary life forms, by transforming ecosystems as they wish. But the attempts all fail, one after the other, and irremediably destroy the most fragile ecosystems. The only successes are obtained on virgin worlds, but on which water and humus must also be brought to make them viable.

After much effort, the struggle for the survival of their home planet finally succeeds in restoring a self-sustaining ecosystem, but the sun is also fading, with no possibility of solving this problem. The inhabitants, concentrated in overpopulated hives, decide to emigrate to already inhabited worlds.

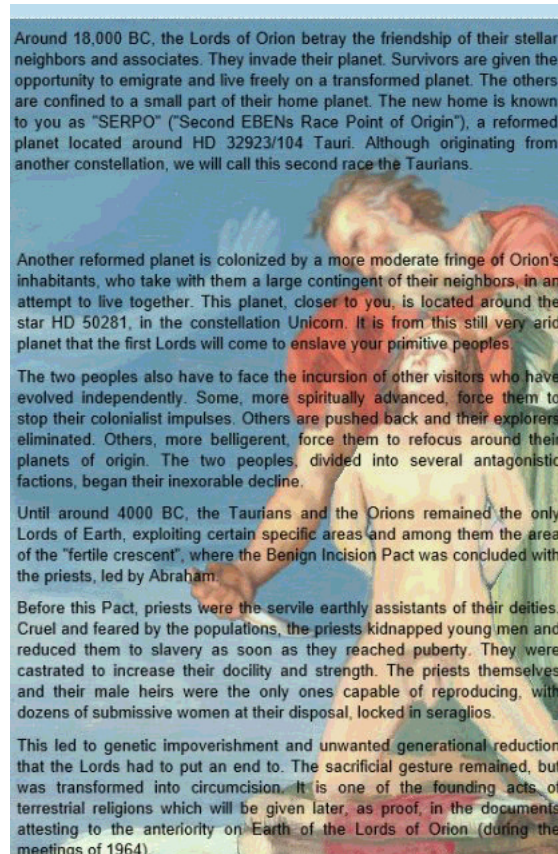


Figure 20.17: Second text part of the 'Oritau' report (11/2023). The drawing in the background is a modification of the painting *The Sacrifice of Isaac*, by Hypolit Flandrin (early 19th century), altered to suggest castration instead of human sacrifice.

SECOND PART (Fig. 20.17):

Around 18,000 BC, the Lords of Orion betray the friendship of their stellar neighbors and associates. They invade their planet. Survivors are given the opportunity to emigrate and live freely on a transformed planet. The others are confined to a small part of their home planet. The new home is known as "SERPO" ("Second EBENs Race Point of Origin"), a reformed planet located

around HD 32923/104 Tauri. Although originating from another constellation, we will call this second race the Taurians.

Another reformed planet is colonized by a more moderate fringe of Orion's inhabitants, who take with them a large contingent of their neighbors, in an attempt to live together. This planet, closer to you, is located around the star HD 50281, in the constellation Unicorn. It is from this still very arid planet that the first Lords will come to enslave your primitive peoples.

The two peoples also have to face the incursion of other visitors who have evolved independently. Some, more spiritually advanced, force them to stop their colonialist impulses. Others are pushed back and their explorers eliminated. Others, more belligerent, force them to refocus around their planets of origin. The two peoples, divided into several antagonistic factions, began their inexorable decline.

Until around 4000 BC, the Taurians and the Orions remained the only Lords of Earth, exploiting certain specific areas and among them the area of the "fertile crescent", where the Benign Incision Pact was concluded with the priests, led by Abraham.

Before this Pact, priests were the servile earthly assistants of their deities. Cruel and feared by the populations, the priests kidnapped young men and reduced them to slavery as soon as they reached puberty. They were castrated to increase their docility and strength. The priests themselves and their male heirs were the only ones capable of reproducing, with dozens of submissive women at their disposal, locked in seraglios.

This led to genetic impoverishment and unwanted generational reduction that the Lords had to put an end to. The sacrificial gesture remained, but was transformed into circumcision. It is one of the founding acts of terrestrial religions which will be given later, as proof, in the documents attesting to the anteriority on Earth of the Lords of Orion (during the meetings of 1964).

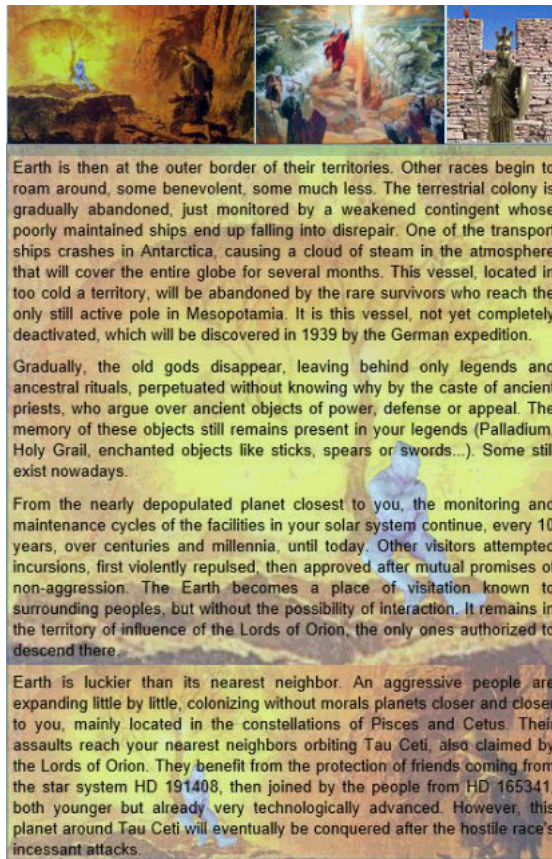


Figure 20.18: Third text part of the 'Oritau' report (11/2023).

THIRD PART (Fig. 20.18):

Earth is then at the outer border of their territories. Other races begin to roam around, some benevolent, some much less. The terrestrial colony is gradually abandoned, just monitored by a weakened contingent whose poorly maintained ships end up falling into disrepair. One of the transport ships crashes in Antarctica, causing a cloud of steam in the atmosphere that will cover the entire globe for several months. It is this vessel, located in too cold a territory, will be abandoned by the rare survivors who reach the only still active pole in Mesopotamia. It is this vessel, not yet completely deactivated, which will be discovered in 1939 by the German expedition.

Gradually, the old gods disappear, leaving behind only legends and ancestral rituals, perpetuated without knowing why by the caste of ancient priests, who argue over ancient objects of power, defense or appeal. The memory of these objects still remains present in your legends (Palladium, Holy Grail, enchanted objects like sticks, spears or swords...). Some still exist nowadays..

From the nearly depopulated planet closest to you, the monitoring and maintenance cycles of the facilities in your solar system continue, every 10 years, over centuries and millennia, until today. Other visitors attempted incursions, first violently repulsed, then approved after mutual

promises of non-aggression. The Earth becomes a place of visitation known to surrounding peoples, but without the possibility of interaction. It remains in the territory of influence of the Lords of Orion, the only ones authorized to descend there.

Earth is luckier than its nearest neighbor. An aggressive people are expanding little by little, colonizing without morals planets closer and closer to you, mainly located in the constellations of Pisces and Cetus. Their assaults reach your nearest neighbors orbiting Tau Ceti, also claimed by the Lords of Orion. They benefit from the protection of friends coming from the star system HD 191408, then joined by the people from HD 165341, both younger but already very technologically advanced. However, this planet around Tau Ceti will eventually be conquered following the hostile race's incessant attacks.

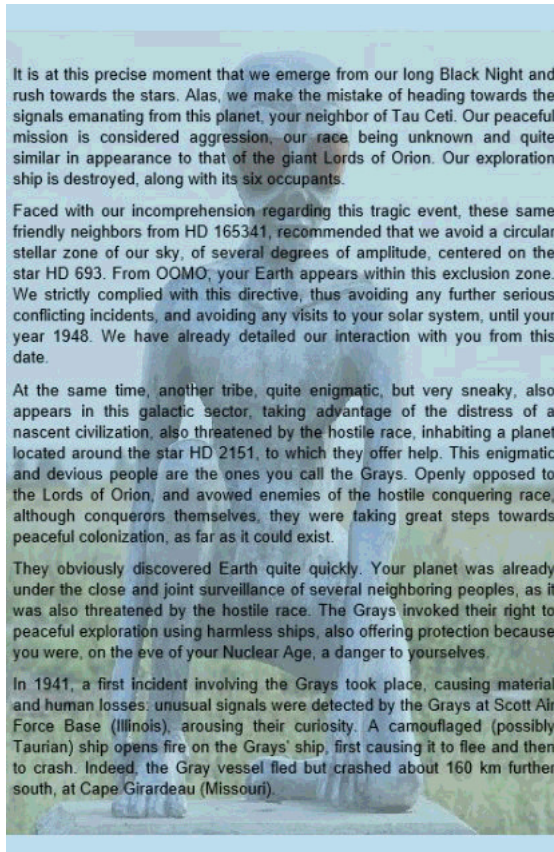


Figure 20.19: Fourth text part of the 'Oritau' report (11/2023).

FOURTH PART (Fig. 20.19):

It is at this precise moment that we emerge from our long Black Night and rush towards the stars. Alas, we make the mistake of heading towards the signals emanating from this planet, your neighbor of Tau Ceti. Our peaceful mission is considered aggression, our race being unknown and quite similar in appearance to that of the giant Lords of Orion. Our exploration ship is

destroyed, along with its six occupants.

Faced with our incomprehension regarding this tragic event, these same friendly neighbors of HD 165341, recommended that we avoid a circular stellar zone of our sky, of several degrees of amplitude, centered on the star HD 693. From OOMO, your Earth appears within this exclusion zone. We strictly complied with this directive, thus avoiding any further serious conflict incidents and avoiding any visits to your solar system, until the year 1948. We have already detailed our interaction with you from this date.

At the same time, another tribe, quite enigmatic, but very sneaky, also appears in this galactic sector, taking advantage of the distress of a nascent civilization, also threatened by the hostile race, inhabiting a planet located around the star HD 2151, to which they offer help. This enigmatic and devious people are the ones you call the Grays. Openly opposed to the Lords of Orion, and avowed enemies of the hostile conquering race, although conquerors themselves, they were taking great steps towards peaceful colonization, as far as it could exist.

They obviously discovered Earth quite quickly. Your planet was already under the close and joint surveillance of several neighboring peoples, as it was also threatened by the hostile race. The Grays invoked their right to peaceful exploration using harmless ships, also offering protection because you were, on the eve of your nuclear age, a danger to yourselves.

In 1941, a first incident involving the Grays took place, causing material and human losses. unusual signals were detected by the Grays at Scott Air Force Base (Illinois), arousing their curiosity. A camouflaged (possibly Taurian) ship opens fire on the Grays' ship, first causing it to flee and then to crash. Indeed, the Gray vessel fled but crashed about 160 km further south, at Cape Girardeau (Missouri).

In connection with this long period of slavery of terrestrial humanity under the dominion of Orion/Taurus (Oritau), the answer given by 312_oay to a question about the recurrent representations of enigmatic ancestral figures *carrying a bag* is undoubtedly relevant. These have appeared both in Gobekli Tepe (present-day Turkey, near Syria), with a dating of 10,000 years B.C., and among the Sumerians and Mexicans thousands of years later. The question (Fig. 20.20) posed is: *“We believe that the Göbekli Tepe carvings represent Orion travelers. Do the types of bags, often referred to as ‘bags of the gods’, seen in numerous archaeological sites around the world represent specific devices? And, if so, what is their function? @312_oay.”*

The answer to the question can be found in tweet 312-125 (Fig. 20.21):

“These depictions recall the time when humanity was enslaved. With no time to forage for their own food, people were given ceremonial meals by the lords or their master-servants in the form of clusters of sweet, nutritious, and relaxing dumplings served in such portable cauldrons.”

20.10 Israel and the Vatican after the revelations

One of the stories that circulate within the most “fantastic” ufological literature — in particular, in the context of the information about the SERPO project — is the existence of a “Yellow Book”

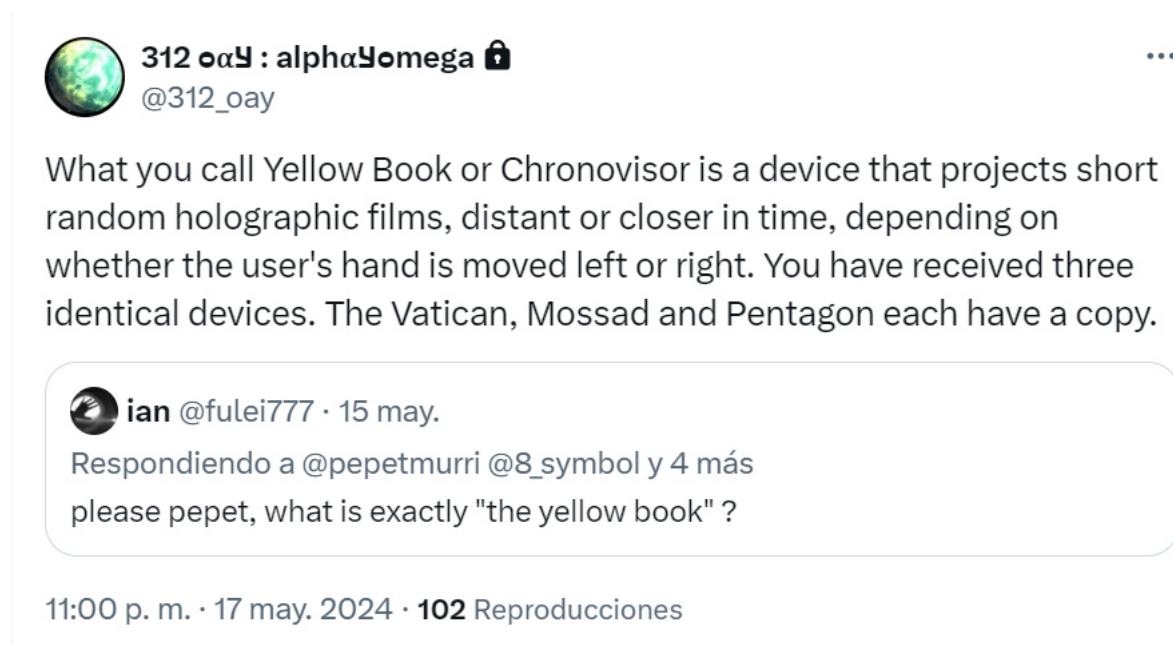


Figure 20.22: Tweet 312-122 (05/2024).

donated by the Reptilians to the U.S. authorities. This would be an audiovisual device that stores images of a large part of Earth's history. In another order of things, there has long existed the legend of the "Chronovisor", a mysterious device in the possession of the Vatican that shows images of the past. We will see that both objects converge in the same reality. Tweet 312-122 (Fig. 20.22):

"What you call Yellow Book or Chronovisor is a device that projects short random holographic films, distant or closer in time, depending on whether the user's hand is moved left or right. You have received three identical devices. The Vatican, Mossad and Pentagon each have a copy."

Subsequently, the following two tweets are posted (Figs. 20.23 y 20.24):

"The main leaders of Israel and the Vatican suddenly discovered that the roots of their beliefs are untrue. The two parties reacted with hatred against God, rejecting all the alleged Commandments, challenging Him to prove His true existence by pretending to worship His antithesis."

"These two micro-states, whose geostrategic importance is overrepresented on a global scale, base their legitimacy on a large group of believers, most of them in good faith, by knowingly deceiving them about the veracity of their beliefs, thus extorting their voluntary submission."

20.11 Orion is coming now

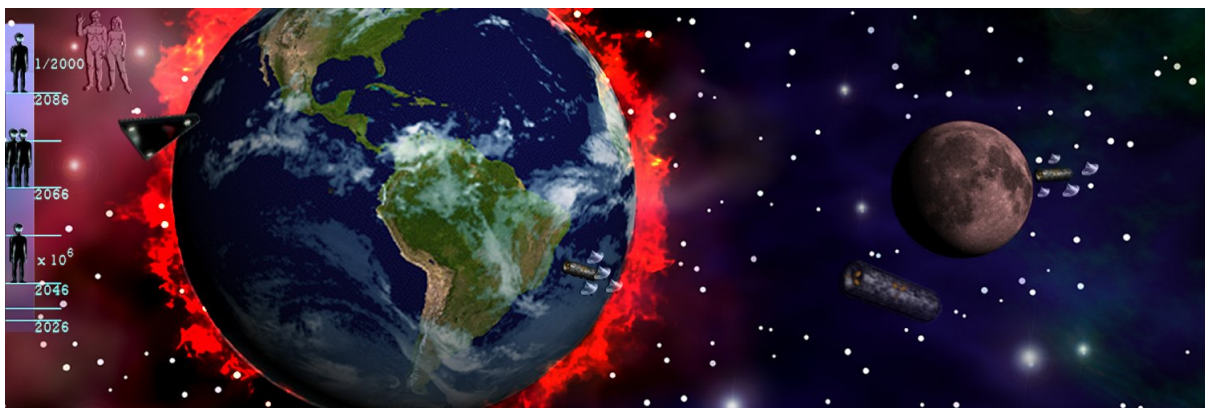


Figure 20.25: New background image of the @oyagaaayuyisaa account (1/2024).

On January 21, 2024 a new background image or 'banner' appeared on the @oyagaaayuyisaa account, as shown in Fig. 20.25.

Two novelties are observed. First, a contingent of discoidal and cylindrical-shaped spacecraft, with the symbol of the clover — therefore, presumably Gray —, has gathered on the dark side of the moon, while another contingent seems to hover over the South American continent. Secondly, a classic triangular craft with three spotlights at the apexes appears on the left side of the globe. It is assumed that this ship is Reptilian (from Orion). This hypothesis is supported by the background image in 20.16, where two similar ships appear (lower half). In addition, on the ship of 20.25, a kind of red 'delta wing' is observed as an insignia that could be assimilated to an open triangle, distinctive, as has been said, of all the ships related to Orion.

This modification of the 'banner' could indicate that, after the more or less massive arrival of Grays, Orion is also beginning to send its expeditionaries, all this on the verge of the year 2026, when it should be decided which of the two civilizations settles on Earth (or, what would be infinitely more desirable, neither of them).


20.12 Guests on bases

A recurring "legend" from the field of *exopolitics* speaks of hypothetical ET colonies living on U.S. military bases (including, of course, Area 51). In tweet 312-194, while basically refuting Charles J. Hall's stories about the so-called "Tall Whites" (a concept probably constructed from the genuine Orions or Reptilians), the Oomoans confirm this fact, however (Fig. 20.26):

In response to a news item in *Le Point* that reads: “Why does Donald Trump covet Greenland? The U.S. president-elect believes that ‘ownership and control’ of this island is ‘an absolute necessity for the security of the country’,³” user @sapo_revolution reflects:

“Yes. That would explain a lot. This is the ideal solution.” (to host visitors...) This comment led to tweet 312-142 (Fig. 20.35):

Before closing the accounts, prior to his announced departure from Earth, 312 changed, during the last few hours, the profile picture of the account, as well as the text of the biography; see Fig. 20.38.

The text *almost* replicates that of Crabwood's famous "crop circle" (see Chapter 14), which read, *Beware of Bearers of False Gifts and of their Broken Promises. Much Pain but still Time . - BELIEVE-. There is good out there. We Oppose Deception. Conduit Closing... (bell sound)*. Now the text has been modified like this:

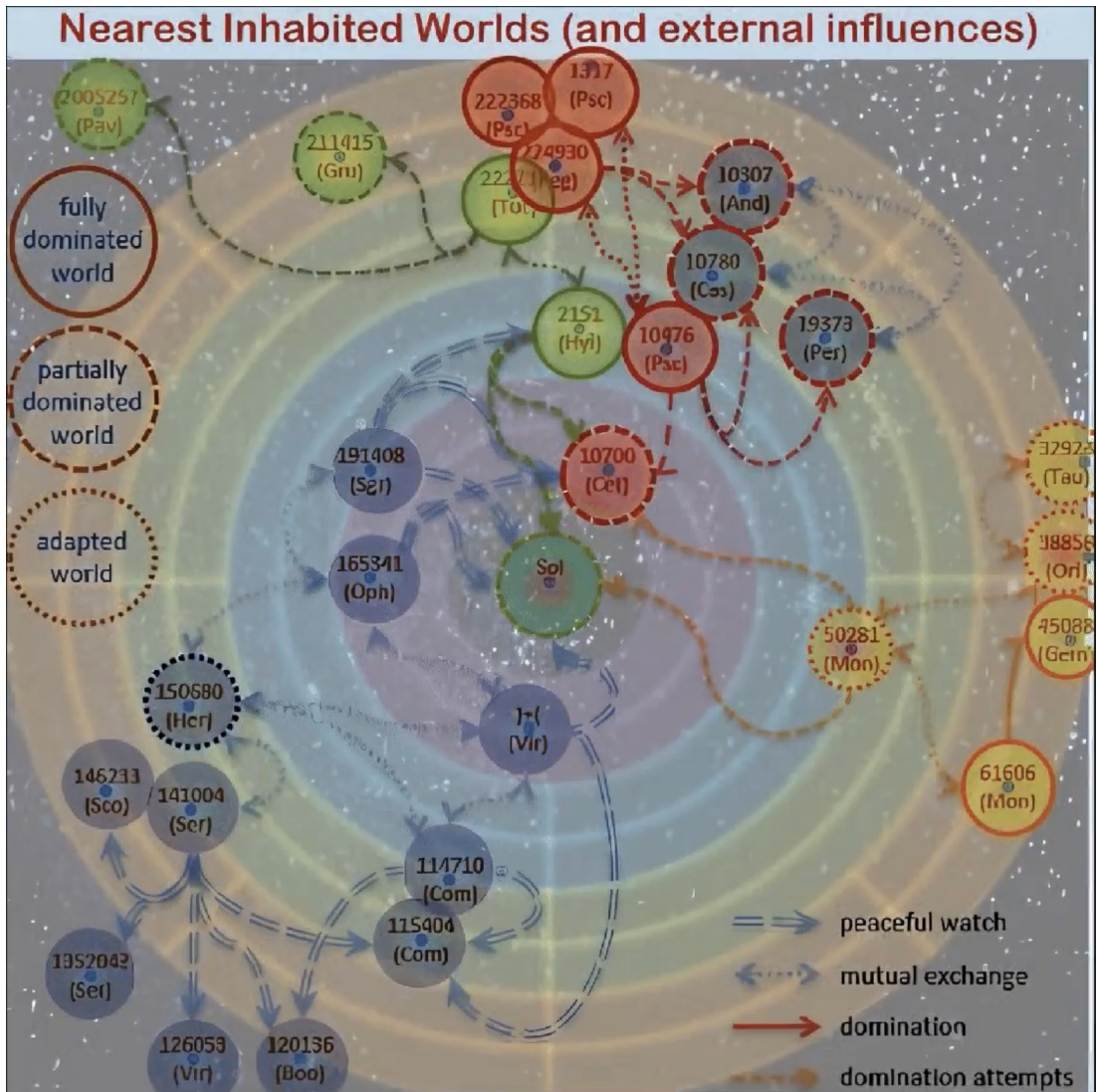


Figure 20.39: Near worlds and external influences.

The profile picture, on the other hand, under the heading *“Nearest Inhabited Worlds (and external influences),”* replaces the representation of the planet OOMO by a schematic picture with some stars close to the Sun, indicating the relations of the corresponding civilizations among them and with the Earth (Fig. 20.39, improved by the user @L_Y_E_S_H). Thus, for example,)+((OOMO, orbiting IUMMA) appears in gray, showing its mutual exchange relations with 70 Ophiuchus (HD165341), the race that advised them at the time not to travel in the direction of Earth (see Section 20.9), as well as with HD191408 (or HR7703), also mentioned in that Section. The latter civilization is the one who shares (shared) the Antarctic refuge with the Oomoans, without mixing with the terrestrial social network; see

<https://ummo-ciencias.org/Cartas/W2.html>, OAY-126.

(According to an old “Saliano” letter, the name of its planet is IOX, and its inhabitants — always according to this letter — “are tall, very intelligent and with very strict moral standards”.) Also shown is the terraformed planet (“adapted world”) DOOKAAIA (HD150680), on which three benevolent civilizations are experimenting in collaboration: OOMO, the aforementioned HD165341 and, as deduced from the schematic, HD141004 (see <https://ummo-ciencias.org/Cartas/W3.html>), OT-100).

Hostile domain stars are shown in red. Interestingly, nearby Tau Ceti (HD10700) is shown as “partially dominated” by the hostile domain, but, at the same time, under “attempted domination” by HD2151 (Beta Hydri), a world of the Grays — in green — so that its status is not clear (see also 20.9, part 3). Stars associated with the Reptilian or Orion domain are shown in yellow. We distinguish, in particular, HD61606, the first of its colonies and currently the most populated planet in this domain, as indicated in Chapter 7. We can also see HD50281, the planet, now abandoned, from which the visitors to Earth have come. As already mentioned several times, the terraformed planet HD32923 is SERPO.

As can be seen, unfortunately the Sun (Earth) already appears as a world *partially dominated* by the Grays (and also under the tentacles of Orion). This situation must be reversed before July 2026, or our world will be fatally doomed.
